

# TENNESSEE ALCOHOLIC BEVERAGE COMMISSION MEETING MINUTES THURSDAY, JANUARY 25, 2018 1:30 p.m.

The meeting was held on Thursday, January 25, 2018, in Nashville, Tennessee. Commissioner Jones and Commissioner Skiles were present and constituted a quorum. Present on behalf of staff were the following: Director Byrd, Assistant Director Blair, CLEO Tubbs, Joshua Stepp, Keith Hollingshead-Cook, Mark Reineke, Nancy Townsend, John Pallas, Nichelle Dorroh, Nancy Townsend, and Christopher Dowell.

**Discussion/Action Taken:** Commissioner Jones called the meeting to order and made a motion to nominate Richard Skiles to serve as Chairman of the Commission. Commissioner Skiles seconded the motion. The motion passed with two ayes.

**Discussion/Action Taken:** Commissioner Jones noted that the requested addendum to the December meeting minutes was included as part of the minutes and Commissioner Jones made a motion to accept the minutes as presented. Chairman Skiles seconded the motion and it passed with two ayes.

Before the Commission is a request for approval of a new retail package store to be located at 11370 Parkside Dr., Knoxville, TN 37934. The applicant is leasing the premises from Hart TC I-III, LLC. The TABC staff recommends conditional approval of the license subject to receipt of the following items:

- a. agent report
- b. inspection & acknowledgment of rules & regulations
- c. certificate of occupancy
- d. license fee
- e. responsible vendor certification

**Discussion/Action Taken:** Director Byrd introduced the matter to the Commission and asked Commission Counsel, Keith Hollingshead-Cook, to provide background on the litigation and Mr. Hollingshead-Cook then addressed the Commission before turning the floor back over to Director Byrd.

Director Byrd recommended conditional of the license subject to receipt of the agent report, inspection which includes the acknowledgment of rules & regulations, certificate of occupancy, license fee, and responsible vendor certification.



A brief discussion was held regarding the certificate of occupancy and inspection requirement.

Attorney Bill Hubbard addressed the Commission on behalf of the applicant and commented that he did not anticipate any issues with the certificate of occupancy.

Representatives of the Tennessee Wine and Spirits Retailer's Association requested to address the Commission in opposition of the application. Attorney Rick Colburt then addressed the Commission and argued several points relating to the applicant's alleged non-disclosure of violations, the pending residency case in the Court of Appeals, and the trust beneficiaries being minors.

A discussion was held.

Commissioner Jones motioned to approve the license subject to satisfactory performance of those items that are listed and all the proper paperwork being presented and moved to approve the license upon acceptance of those items as stated. Chairman Skiles seconded the motion. The motion was approved with two ayes.

Retail package store licensee no. 1064 located at 13044 Kingston Pike, Knoxville, TN 37934 has two requests before the Commission. First, the applicant is requesting approval for changes in shareholders and shareholder interest. After the transfers Linda G. Taylor will no longer be a shareholder in the corporation.



Additionally, the applicant would like to change the d/b/a name. The TABC staff recommends approval of both requests.

**Discussion/Action Taken:** Director Byrd reviewed the matter and recommended approval of the change in shareholders and shareholder interest. Commissioner Jones moved for approval and Chairman Skiles seconded the motion. The motion passed with two ayes.

Director Byrd recommended approval of the d/b/a name change. Commissioner Jones motioned for approval and Chairman Skiles seconded the motion. The motion passed with two ayes.

### 6. RICHLAND WINE AND SPIRITS DAYTON, TENNESSEE (RHEA COUNTY)

Before the Commission is a request for licensing of a new retail package store to be located at 260 16th Avenue Suite 138, Dayton, TN 37321. While a local Certificate of Compliance has not been granted by the city of Dayton, the applicant contends the Certificate should be deemed granted pursuant to T.C.A. § 57-3-208(d)<sup>1</sup>. This matter is currently the subject of a legal action in the city of Dayton. The TABC staff recommends that this matter be continued until such time as the court in the pending matter provides further clarity regarding this issue or the legal matter is otherwise resolved.

**Discussion/Action Taken:** Director Byrd reviewed the matter to the Commission and recommended the matter be continued until the next Commission meeting. Director Byrd noted that the applicant had not submitted a certificate of compliance with the application and that there is a dispute at the local level and that it is not timely for the Commission to consider the application at this time. Commission Counsel Stepp clarified that the staff is recommending that the matter be continued until the lawsuit is resolved or clarification regarding the injunction is received. Commissioner Jones moved for the item to be postponed until such time staff deems it can be properly brought before the Commission. Chairman Skiles seconded the motion and it passed with two ayes.

**Discussion/Action Taken:** Director Byrd reviewed the matter to the Commission and recommended conditional approval of the application upon receipt of the listed conditional items. Attorney Danielle Elks requested to speak in opposition of the application. Applicants Makram Gendy and Hany Daoud were in attendance.

Danielle Elks addressed the Commission is opposition to the application citing public safety concerns and concerns about the applicants financial viability to operate the store. Ms. Elks requested the Commission set the matter for a show-cause hearing.

A discussion was held in which Director Byrd, Makram Gendy, Commission Counsel Joshua Stepp, and Danielle Elks addressed the Commission.

After the discussion, Director Byrd recommended conditional approval of the application.

Commissioner Jones moved for approval subject to receipt of any documentation that is missing. Commissioner Skiles seconded the motion and the motion was approved with two ayes.

<sup>&</sup>lt;sup>3</sup> T.C.A. § 57-4-102(8)(A) "Club" means a nonprofit association organized and existing under the laws of the state of Tennessee, which has been in existence and operating as a nonprofit association for at least two (2) years prior to the application for a license hereunder, having at least one hundred (100) members regularly paying dues, organized and operated exclusively for pleasure, recreation and other nonprofit purposes, no part of the net earnings of which inures to the benefit of any shareholder or member; and owning, hiring or leasing a building or space therein for the reasonable use of its members with suitable kitchen and dining room space and equipment and maintaining and using a sufficient number of employees for cooking, preparing and serving meals for its members and guests; provided, that no member or officer, agent or employee of the club is paid, or directly or indirectly receives, in the form of salary or other compensation, any profits from the sale of spirituous liquors, wines, champagnes or malt beverages beyond the amount of such salary as may be fixed by its members at an annual meeting or by its governing body out of the general revenue of the club. For the purpose of this section, tips which are added to the bills under club regulations shall not be considered as profits hereunder. The premises, as provided in § 57-4-101(a)(2) for a club, shall also include the golf course, tennis courts and the area immediately surrounding the swimming pool, if a club offers such amenities. The alcoholic beverage commission shall have specific authority through rules and regulations to define with specificity the terms used herein and to impose additional requirements upon applicants seeking a club license not inconsistent with the definition above;
