- Effective upon the issuance of the letter, any wholesaler shall be permitted to solicit orders, and sell and deliver, wine for this retail food, provided that orders of wine may only be made by permitted managers. Any wine sold and delivered to the retail food store may not be accessible for sale to the public until the retail food store holds a validly issued retail food store wine license. The retail food store may stock wine on the shelves as long as signage is posted advising the public that no wine may be sold prior to July 1, 2016, and steps are taken by the retail food store to ensure that no sales take place.

The letter grants approval for a license for this retail food store, conditioned upon the following:

- a. No license shall be issued, or if issued effective, before July 1, 2016.
- b. The retail food store must submit any remaining items with regards to their application to the TABC's satisfaction.
- c. The retail food store must be an approved Responsible Vendor.

Despite the preliminary approval, the retail food store may not receive a license pursuant to T.C.A. § 57-3-803, if cause exists to contest the issuance of the license, including, but not necessarily limited to, if any of the above conditions that have been placed upon such approval has not been met. In the event that the retail food store does not receive a license for such reasons, then, pursuant to T.C.A. §§ 57-3-807 and 57-3-204(d), the applicable wholesaler shall repurchase and remove the saleable alcoholic beverages in the possession of the retail food store.
