**1. REVIEW/APPROVAL OF THE OCTOBER 26 COMMISSION MEETING MINUTES**

**Discussion/Action Taken: Commissioner Hamilton moved to approve both minutes and the motion was seconded. The motion passed with three ayes.**

The TABC staff has determined that Alberto Forero will have an indirect interest in the proposed business and cannot recommend approval until he is added to the application. The TABC staff recommends this matter be continued for the purpose of adding any and all indirect interest holders.

**Discussion/Action Taken:** Director Thomas summarized the request and recommended continuing the matter for the purpose of adding any and all indirect interest holders. Counsel for the applicant, Adam Dread, said that Mr. Forero would not be looking into the books or anything for the purchaser of his store. Chairwoman Roberts said in looking at finances that Mr. Forero had indirect interest in the store despite selling it to the member listed on the application. Commissioner Tomita moved to continue the matter for the purpose of adding any and all indirect interest holders and the motion was seconded. The motion passed with three ayes.

TABC staff has determined that Amanjullah Devji will have an indirect interest in the proposed business and cannot recommend approval until he is added to the application. The TABC staff recommends this matter be continued for the purpose of adding any and all indirect interest holders.

**Discussion/Action Taken:** Director Thomas summarized the request and recommended continuing the matter for the purpose of adding any and all indirect interest holders. Counsel for the applicant, Danielle Elks, spoke about the concerns in relation to Amanjullah Devji being added. Amanjullah Devji, via Microsoft Teams, spoke as well and argued that he did not have an indirect interest in the business. After continuing on, Commissioner Tomita intervened and said we need to be consistent in adding any indirect interest members, which is the case here like it was in the previous matter. Commissioner Hamilton moved to continue the matter 60 days for the purpose of adding any and all indirect interest holders and the motion was seconded. The motion passed with three ayes.

The applicant has failed to provide sufficient information for staff to verify their financial viability and the presence of any additional interest holders. Therefore, the TABC staff recommends denial of the application.

**Discussion/Action Taken:** Director Thomas summarized the request and recommended denial of the application. Mr. Sachin Patel, via Microsoft Teams, spoke about the information he submitted to the TABC and trying to get his license. However, Commission Counsel member Joshua Stepp said that the information provided was both not helpful and not enough. Commissioner Tomita moved denial and the motion was seconded. The motion passed with three ayes.

It is the opinion of staff that this applicant is not financially viable and there may be additional interest holders that should be provided on the application. Therefore, the TABC staff recommends denial of the application.



**Discussion/Action Taken:** Director Thomas summarized the request and recommended denial of the application. Mr. Bassem Awad, the applicant, was in-person at the meeting and stated that the information sent to the TABC was valid. However, Commission Counsel member Joshua Stepp said that the information provided was both not helpful and raised concerns about financial viability. Commissioner Tomita moved to continue the matter 60 days for the applicant to provide the TABC documentation showing financial viability and any additional interest holders and the motion was seconded. The motion passed with three ayes.
