Highlights

- TDA is maintaining a list of resources to address livestock needs and continuing to monitor county requests through TEMA.
- Ag Crime continues to assist with livestock supply distribution, livestock control, and damage assessment.
- TDA is coordinating with Disaster Animal Response Teams to provide staffing at donation and distribution sites.
- The UT mobile vet unit is providing veterinary services to both small animals and livestock in Carter County.
- Commodities staff are assisting in coordination of food and feeding sites for citizens and first responders in Carter and Unicoi Counties.
- Food Safety staff are canvassing affected areas to provide educational materials and guidance to licensed firms to help them safely resume food manufacturing and preparation operations.
- A second TAEP application period will be offered Dec. 2-6 to affected farmers in Carter, Claiborne, Cocke, Grainger, Greene, Hamblen, Hawkins, Jefferson, Johnson, Sullivan, Unicoi, and Washington Counties.*

*(*counties align with Governor Lee's requests for federal disaster declarations and public assistance)*

How To Help

Farmers must **register with FEMA** to be eligible for USDA Farm Services Agency programs for livestock and crop loss. The **Crisis Clean-Up Hotline (844) 965-1386** has been established for survivors to access free assistance with clean-up efforts.

Survivors in Carter, Cocke, Green, Hamblen, Hawkins, Johnson, Unicoi, and Washington counties can apply for **FEMA Individual Assistance** for rental assistance, home repair, and personal property replacement, in addition to other uninsured or underinsured disaster losses.

- Apply by phone at 1-800-621-3362 between 7 a.m. – 11 p.m. ET. Multilingual operators are available.
- Apply in person at a Multi-Agency Resource Center (details below).

The Tennessee Emergency Management Agency (TEMA) has established two **Multi-Agency Resource Centers (MARC)**s for individuals affected by Hurricane Helene. Each MARC will be staffed with federal, state, and regional partners to assist residents affected by the storm. TEMA is working to identify additional MARC locations.

The MARCs are open 7 a.m. – 7 p.m. ET, Monday – Saturday and Noon – 5 p.m. ET on Sunday.
