Genetics

Assists producers in improving the genetics in their operations, increasing the quality, value, marketability, and reputation of Tennessee livestock.

FY06 - FY22: 17,824 projects — \$20,013,267

Livestock Equipment

Improves a farmer's ability to manage livestock properly and safely on the farm with items like squeeze chutes, creep feeders, feed bins, and working systems.

FY06 - FY22: 37,250 projects — \$70,889,592

Hay Equipment

Assists farmers in improving hay production.

FY20 - FY22: 2,767 projects — \$14,310,932

Hay Storage

Assists farmers in building hay barns, improving storage and management of forages critical to improving herd nutrition.

TAEP Overview

Please read this application booklet as there are changes to requirements and program items.

Updates for 2023-2024

Eligibility Requirement #4 – Farm Operation clarification

- To operate a farm means to share in the expenses, profits, and/or management of farm operation.
 - A farm may involve the production of multiple agricultural products and may have more than one location in Tennessee.
 - A diversified farm with multiple species of livestock, crops, and/or multiple locations is considered a single operation regardless of tax filings or organizational structure.
- **If two or more individuals participate in the operation of the farm, only one individual is eligible to apply for TAEP Application A cost share.**

Reimbursement Requirements #2 – Receipt clarification

- Quotes and purchase orders do not represent a purchase and are not considered receipts.
- Proof of payment may be required.

Verification Requirements – Compliance clarification

- Applicants who fail to comply with minimum use requirements may be required to repay any portion of or all of funds distributed to them under TAEP.
- Failure to comply with all aspects of the cost share guidelines may result in denial of applicant approval, denial of reimbursement payments, repayment of cost share funds, and/or suspension from future TAEP funding cycles.
- Providing any false, fraudulent, or misleading information may result in suspension of applicant's operation, civil litigation, and/or criminal prosecution.

Beginning Farmer Option

- Qualifying applicants will be eligible for select programs (Genetics, Livestock Equipment, & Row Crop Solutions).

Livestock Equipment

- Added self-unloading inline hay trailer
- Reprioritized eligible items to focus on long term investments
- Removed the eligibility of used items due to verification concerns
- Added minimum purchase requirements for select items for best practice management

Genetics

- Breeds with Genomic Enhanced EPDs (GE-EPD) – eligible GE-EPDs required for cost share reimbursement up to \$2,000 (\$1,000 reimbursement for 0.15 accuracies is not available).
- Breeds that do not offer Genomic Enhanced EPDs – eligible true NCE EPDs with minimum 0.15 accuracies required for cost share reimbursement up to \$1,000.
- Bulls must have eligible EPDs between October 1, 2023 and date of purchase date.
- Bulls that do not meet all eligibility requirements between October 1, 2023 and date of purchase will be denied cost share reimbursement.
- **Buyer must communicate with the seller prior to purchasing to ensure bull meets all TAEP eligibility requirements.**

Working Structures & Fence-line Systems

- Formerly "Permanent Working Structures"
- Added fence-line concrete bunk and hay feeding systems which were previously available in Livestock Solutions

Hay Equipment

- Added hay accumulator, hay grapple, multi bale hay spear
- Quotes and purchase orders do not represent a purchase and are not considered receipts.
- **A receipt is required for cost share reimbursement.**

Poultry Grower

- Added program back to Application A after eight years as a separate application booklet (Application C)
- Allows applicants the option to apply online

Swine Producer

- Created standalone program for swine which were previously under Livestock Solutions
- Added curtains, farrowing crates, farrowing crate flooring, feed bin, feed bin scales, heaters, manure/lagoon pump, manure spreader/injector, nursery pens, propane tanks, ventilation fans, ventilation doors

Reimbursement Maximums

Each program has a reimbursement payment maximum. The amount of payment is based upon a cost share percentage (35% or 50%) of expenses incurred for eligible program items.

Final program reimbursement maximums will be determined based upon overall demand for cost share funding and specified on approval documentation.

Cost Share Percentages & Master Certification

All approved applicants are eligible for 35% (Standard Producer) cost share with the exception of applicants approved for the Beginning Farmer Option. For applicants wanting to qualify for 50% cost share (Master Producer), an eligible master producer certificate is required at time of reimbursement (not at time of application). Courses to obtain certificates must be completed by the applicant. Certificates must be issued after January 1, 2020 to be considered current for TAEP. See pp. 8 & 9 for additional information on master producer requirements.

Applicants qualifying for the Beginning Farmer Option will be reimbursed at 50% cost share and must complete the required educational certification (UT Farming Fundamentals or TSU New Farmer Academy) by the reimbursement deadline to qualify for reimbursement. There will not be a 35% cost share option. See pp. 10-11.

Program Change

Applicant will not be allowed to change program request after the application period ends on October 7, 2023.

Application Period

The 2023 application period is open for seven days: October 1-7, 2023.

Eligible Purchase Dates

Program purchases can be made starting October 1, 2023. All purchases must be completed by the program reimbursement request deadline. **All receipts must be in the name of the applicant approved for cost share funding.**

Approval Notifications

Approval notifications are scheduled to be mailed in mid-December. Reimbursement packets will be mailed in January 2024.

Reimbursement Request Deadlines

The reimbursement request deadline for Livestock Equipment and Hay Equipment is April 1, 2024. The reimbursement request deadline for Genetics is June 1, 2024. All other TAEP programs have a reimbursement deadline of August 1, 2024.

Eligibility Requirements

1. Applicant must be a citizen of the United States of America or lawfully present in the United States.
2. Applicant must be at least 18 years old at time of application.
3. Applicant must be a Tennessee resident residing in Tennessee. *Documentation, including a current Tennessee Driver/Identification license, may be requested to verify applicant has established residency in Tennessee.*
4. Applicant must be operating a farm* in Tennessee.

*** To operate a farm means to share in the expenses, profits, and/or management of farm production.** *A farm may involve the production of multiple agricultural products and may have more than one location in Tennessee. A diversified farm with multiple species of livestock, crops, and/or multiple locations is considered a single operation regardless of tax filings or organizational structure.*

If two or more individuals participate in the operation of the farm*, only one individual is eligible to apply for TAEP Application A cost share.

5. Applicant must have filed a Federal IRS Schedule F (Form 1040), Profit or Loss from Farming, within the last two years (2021 or 2022).
Applicant will not be required to submit a copy of their Schedule F at the time of application. However, applicant may be asked to submit a copy of their Schedule F prior to TAEP approval to verify their farming operation. If your operation does not file a Schedule F, please contact TAEP about alternate documentation (Schedule C or Schedule K) to verify farming status.
6. Applicant must meet at least one of the minimum livestock/acreage requirements for selected program. Verification of minimum requirements may be requested prior to approval.
 - Head of Livestock = maximum number of single type, regardless of sex or age, at any one time during the last 12 months
 - Hay Acreage = acres of hay production; first cutting only
 - Row Crop Acreage = acres in row crop production of corn, cotton, soybeans, and/or wheat
7. Applicant must have current (not expired) documentation (certificate or permit) based on type of producer at time of application. Documentation must be in the name of the applicant. No substitutions allowed.

Beef Quality Assurance Certification (BQA) for beef and dairy cattle

- BQA certification must be renewed every three years and be current at time of application.
- BQA is an educational class on cattle management and care. Courses are available in-person and online.
- In-person certification – administered in-person by your local UT/TSU Extension office (utextension.tennessee.edu)

Pork Quality Assurance Plus Certification (PQA) for swine

- PQA Plus certifications must be renewed every three years and be current at time of application.
- PQA Plus is a two-hour educational course sponsored by the Tennessee Pork Producers Association (TPPA).

Tennessee Department of Agriculture (TDA) Dairy Permit for dairy cattle, goats, and sheep

- Dairy must be permitted by TDA to be eligible as a dairy at time of application.
 - Contact TDA Consumer and Industry Services Division for dairy permit information at 615-837-5536.

Tennessee Department of Agriculture may:

- Accept, modify, or reject any or all applications or requests.
- Modify program criteria, approval, and payment processes.
- Request additional information from the applicant.
- Provide partial funding that may be less than the full amount requested.
- Deny payments for projects that do not meet requirements.

Program Requirements

Application

1. Applications must be submitted during the application period October 1 – 7, 2023.
 - Applications may be submitted by one of the following methods:
 - Online — October 1 - 7, 2023
 - Mail — applications must have a postmark date ranging from October 1 - 7, 2023
 - Hand delivery between October 1 – 7, 2023 during normal business hours. Contact TAEP office prior to hand delivery in 2023.
 - Applications are not accepted by fax, email, or text.
 - Applications are ineligible if postmarked or received prior to October 1 or after October 7, 2023.
2. Applicant may request one (1) cost share program. **Applicant will not be allowed to change cost share program request after the application period ends on October 7, 2023.**
3. Applicant may only submit one Application A per application period. *Refer to eligibility requirement #4 (p.6) if two or more individuals participate in the operation of the farm.*
4. Applicant will be notified in writing of approval or disapproval. Notifications will be mailed in mid-December. **Applicant must alert TAEP office if notification is not received by mid-January.**
5. Reimbursement packet may include additional program requirements and cost share guidelines.

Reimbursement

1. Receipts dated prior to October 1, 2023 are not eligible. **All items, regardless of backorder status, must be purchased by the program reimbursement deadline.** Backordered items may be ineligible for cost share if not delivered to the farm by the program deadline.
2. Receipts must be in the name of the applicant approved for cost share funding. Quotes and purchase orders do not represent a purchase and are not considered receipts. Proof of payment may be requested to verify purchase.
3. Receipts for in-kind services are not eligible. Trade-in value is not eligible.
4. Used equipment, used materials, and leased equipment are not eligible for cost share reimbursement unless otherwise noted.
5. Labor provided by applicant is not eligible for cost share reimbursement. Labor is for structures only.
6. Applicant cannot be reimbursed for purchases from a business where applicant participates in ownership (producer cooperatives excluded).
7. Applicants cannot combine projects or attach items to another applicant's project. Applicants cannot submit multiple reimbursement requests for the same purchased item.
8. Reimbursement documentation must be postmarked or uploaded to your TAEP Online Account Portal by the reimbursement request deadline. Additional processing time is required for incomplete requests and requests submitted within one month of the program deadline. It is recommended you submit your reimbursement request as soon as your project is completed.
9. There can only be one reimbursement payment per program approval. Projects must be completed by reimbursement deadline.

Verification

1. Applicant must utilize equipment and structures reimbursed with cost share funds for the intended purpose of the program for a minimum of **five (5)** continuous years from date of purchase. Applicants who fail to comply with minimum use requirements may be required to repay any portion of or all of the funds distributed to them under TAEP.
2. Site visits relating to the performance of the project before, during, and after completion may take place. Site visits may include verification of cost share guidelines and program eligibility to ensure applicants meet eligibility and minimum livestock/acreage requirements for chosen program(s).
3. Failure to comply with all aspects of the cost share guidelines may result in denial of applicant approval, denial of reimbursement payments, repayment of cost share funds, and/or suspension from future TAEP funding cycles.
4. Providing any false, fraudulent, or misleading information may result in suspension of the applicant's operation, civil litigation, and/or criminal prosecution.

50% Master Producer Requirements

Master Producer Programs

The University of Tennessee offers several educational programs for the agricultural industry. These programs are designed to provide hands-on experience in current management practices that are important to the profitability and sustainability of the industry.

All approved applicants are eligible for 35% (Standard Producer) cost share with the exception of applicants approved for the Beginning Farmer Option. For applicants wanting to qualify for 50% cost share (Master Producer), an eligible master producer certificate is required at time of reimbursement (not at time of application). Courses to obtain certificates must be completed by the applicant. Certificates must be issued after January 1, 2020 to be considered current for TAEP.

Applicants qualifying for the Beginning Farmer Option will be reimbursed at 50% cost share and must complete a required educational certification (UT Farming Fundamentals or TSU New Farmer Academy) by the reimbursement deadline to qualify for reimbursement. There will not be a 35% cost share option for the Beginning Farmer Option. See pp. 10-11.

50% Master Producer Requirements

Master Certification & TAEP 50% Cost Share

To be eligible for 50% cost share, an approved applicant must complete an eligible master course **prior to submission of their reimbursement request.**

- Certificates must be issued **2020 or after** to be considered current for TAEP.
- Courses to obtain certificates must be completed by the applicant approved for TAEP cost share. No substitutions allowed.
- Copy of current certificate must be submitted with reimbursement request.

Master Producer Recertification

If you received your master certification after **January 1, 2020**, you will be eligible for 50% cost share for the 2023-2024 TAEP program. **Recertification is required if course was completed prior to 2020.**

BQA Certification vs. Master Producer Certification

Beef Quality Assurance (BQA) certification is required at time of application for cattle producers only. Training courses are offered in-person by your local UT/TSU Extension office or online. Course focuses on cattle management and care and is approximately two hours in length.

Master Producer certification is required prior to submission of reimbursement request for applicants seeking to be eligible for 50% cost share. Master Producer certificates are issued by UT/TSU Extension. Course involves multiple education sessions focusing on production and marketing.

Beginning Farmer Option

Beginning Farmer Option

IMPORTANT: If an applicant currently meets the minimum requirements for **any** TAEP Application A program, they **are not eligible** for the Beginning Farmer Option. However, they may apply for the program for which they are eligible.

This program option allows qualifying beginning farmers, who do not meet the current minimum requirements for any TAEP Application A program, the opportunity to participate with **reduced minimum requirements** in select programs (Genetics, Livestock Equipment, or Row Crop Solutions). The purpose of this option is to help the beginning farmer applicant improve their operation with the goal of meeting minimum livestock/acreage requirements in the future.

TAEP allows beginning farmers to participate in the Beginning Farmer Option for **two consecutive** years if they meet the Beginning Farmer Option requirements except for being a first time TAEP applicant.

Beginning Farmer Requirements

To qualify for the Beginning Farmer Option, the applicant must meet basic TAEP eligibility requirements (p. 6) unless otherwise specified below.

- **First time TAEP applicant** — 2023 will be the first year the applicant has applied for TAEP cost share funding.
- **Farming ten years or less** – applicant must be actively involved in the production of row crops and/or livestock at time of application and must have started their farming operation after January 1, 2013.
- **Federal IRS Schedule F (Form 1040) Filing** — applicant must have filed a Federal IRS Schedule F (Form 1040), Profit or Loss from Farming, within the last two years (2021 or 2022) unless the applicant began their operation in 2023. *Applicant may be asked to submit a copy of their Schedule F prior to TAEP approval to verify their farming operation.*
- **Reduced Minimum Requirements** — the program minimum requirements are reduced for applicants qualifying for the TAEP Beginning Farmer Option. Applicant must meet at least one of the minimum livestock/acreage requirements for program applied for.
 - Head of livestock refers to maximum number of single type, regardless of sex or age, at one time during the last 12 months.
 - Goats/Sheep can be combined to meet minimum requirement.

- **Educational Certification Required** — applicant must complete **UT Farming Fundamentals** or **TSU New Farmer Academy** prior to program reimbursement deadline.
 - Applicant who completes the education requirement will be reimbursed at 50% up to the program maximum. *Standard 35% cost share is not available for the Beginning Farmer Option. If you are unable to complete the UT Farming Fundamentals course or attend the TSU New Farmer Academy, your project will not be funded.*
 - Proof of UT Farming Fundamentals or TSU New Farmer Academy certification is required at time of reimbursement (not at time of application). Certificates issued 2020 or after will be accepted.

The program will include resources and information on the essential principles needed to build a successful operation. The topics will include production basics, farm and financial management, marketing basics, taxes, business plan development, and other industry related issues. The **TSU Tennessee New Farmer Academy** is a seven-month certificate program designed for those with an interest in becoming agricultural entrepreneurs. The program focuses on teaching the concepts, providing the information, and facilitating the hands-on experience needed to build solid, viable, and successful agricultural businesses. Guidelines

Allowable purchase dates for Livestock Equipment are from October 1, 2023 – April 1, 2024.

This public service is provided by the UT Department of Animal Science and TAEP. This online tool is found on the **TAEP home webpage** (www.tn.gov/taep).

This tool is intended to be used as a guide to provide information based solely on pedigree data entered by the user. This tool is provided without any guarantees of acceptance. Pedigree must be submitted with reimbursement request and include GE-EPDs (or EPDs with 0.15 accuracies with breeds that do not offer GE-EPDs), indexes, accuracies, genomic verification (if applicable), and have a printed date between October 1, 2023 and the date of purchase.

In addition to a bull meeting EPD, Index, Accuracy, Genomic & Pedigree Print Date qualifications, the bull must also have an eligible BSE, 840 EID tag, and negative test result for BVD-PI.

Trichomoniasis ("Trich") is a venereal disease of cattle caused by the protozoan *Tritrichomonas foetus*, which is transmitted from cow to cow by infected bulls. **This disease reduces calf production by decreasing fertility and inducing abortions.** While heifers usually rid themselves of Trichomoniasis in three to six months, bulls carry the infection for life without showing any symptoms. With no medically approved cures available, detection and control of infected bulls is key to containing the disease. An official sample must be collected by an accredited veterinarian who has been approved by the state. *Trichomoniasis testing is recommended during BSE exam along with submitting ear notch sample for BVD-PI test and securing 840 EID tag for bull.*

Trichomoniasis testing is highly recommended for non-virgin bulls during the BSE exam, 840 EID tag, and BVD-PI testing. All bulls purchased from out of state sources must meet import requirements as set forth by the State Veterinarian's Office.

Guidelines

This is a record keeping reimbursement. Participants must provide complete data when filling out the reimbursement documentation. Reimbursement is based upon a per head payment instead of a cost share percentage.

This program focuses on improving the whole herd health and reputation of Tennessee cattle by encouraging producers to develop a preventative vaccination protocol for their cattle operation. Prioritizing the health and well-being of your cattle is key to a successful operation. A herd health protocol helps to safeguard against sickness and death within the herd.

This program targets all beef and dairy cattle. This program requires basic preventative vaccinations that focus on respiratory diseases, Blackleg, and breeding health. *Producers are encouraged to work with a Tennessee licensed large animal veterinarian to develop a vaccination protocol for their herd.*

What action is required to participate in this program?

Producers will be required to implement the following TAEP Herd Health Protocol and keep records of vaccinations on each individual animal. Information will include: animal identification, sex of animal, date vaccinated, castrated, and dehorned. In addition, producers will be required to list the name, lot number, and expiration date for each product administered for respiratory diseases, Blackleg, and Lepto.

TAEP Herd Health Protocol – Required

1. Vaccination for respiratory diseases for IBR, BVD, PI₃, and BRSV — *all cattle*
2. Vaccination for Blackleg with a 7 or 8 way Clostridial — *required for cattle under 2 years*
3. Vaccination for Lepto — *breeding stock only*
4. Dehorned — *feeder cattle*
5. Castrated — *consult your veterinarian for tetanus recommendations if banding*

Producers are encouraged to combine multiple exams in a single veterinarian visit. For example, Trichomoniasis testing is recommended during BSE exam. It is also recommended to submit ear notch sample for BVD-PI test and secure 840 EID tag for bull during BSE exam.

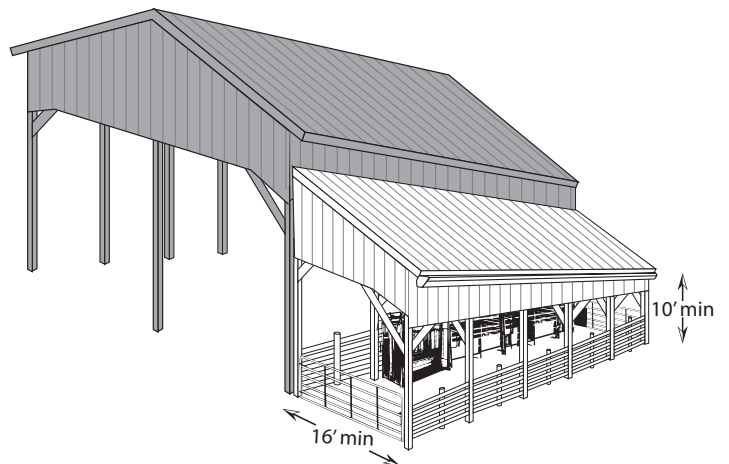

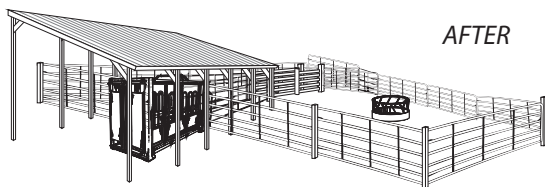
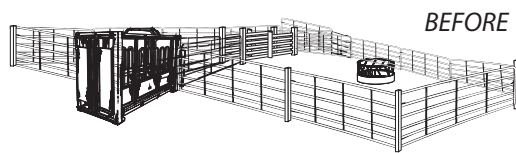
NEW STRUCTURE TO COVER EXISTING EQUIPMENT

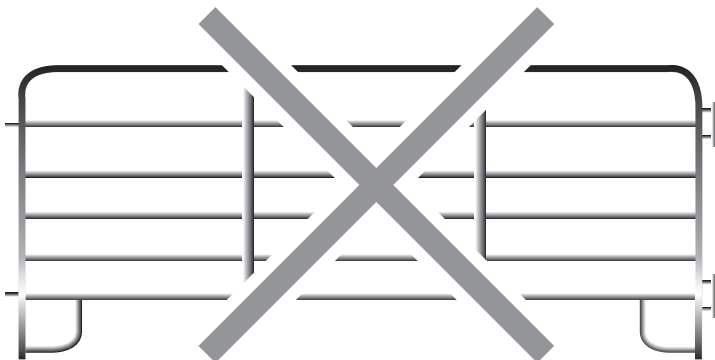

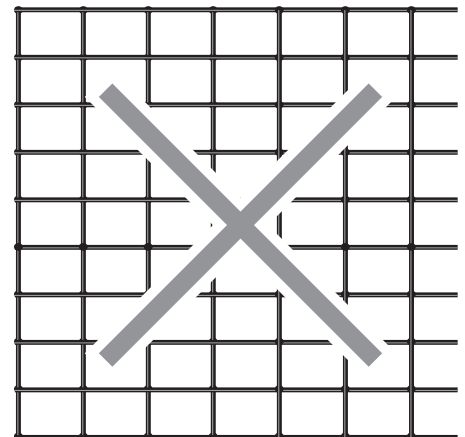

2. Generator — for poultry use only, must be stationary, fixed mounted; minimum of 20 KW per house; concrete pad foundation; includes materials to connect and wire the generator; contract labor to install; *not eligible – portable/PTO generators*
3. Feed bin with optional auger and concrete foundation pad — for on farm storage of poultry feed only; must meet housing and feeding system specifications; contract labor to install; *not eligible – replacement parts*
4. Litter management equipment — must be designated by the manufacturer for poultry house use; equipment includes conveyors/elevators, pull-type spreaders (min. 140-bushel capacity), and poultry specific mounted implements used to windrow, de-cake (house cleaners), till, pulverize, level, and/or scrape walls for optimal litter management; *not eligible – self-propelled equipment, front end loaders, bucket attachments*
5. Overhead trolley system — aid in the removal of mortalities and transport supplies; manual or automated complete system; contract labor to install; *not eligible – electrical service*
6. Feed bin scales — automated feed bin scales and electronics; contract labor to install and interface; *not eligible – electrical service*
7. Poultry scales — automated poultry scales with hanging platform; contract labor to install and interface; *not eligible – electrical service*
8. Environmental pads — reinforced concrete pads for the front/receiving end of the poultry house to allow for better cleaning and disinfection before and after receiving poultry; recommended dimensions: 20' wide x 24' deep (front to back) x 6" thick; reinforced concrete, sloped away from the building; contract labor to install

Eligible Items

9. Poultry house cleaning equipment — must be designated for poultry house use for cleaning, washing down, and disinfecting the interior of the poultry house; minimum 540 RPM PTO driven sprayer and/or blower rigs; sprayer tank size must be a minimum 200 gallon and PTO driven; blower must be hydraulic or PTO driven; spray attachment optional
10. LED lights and dimmer controllers — must be purchased through a poultry supply company and specified for agricultural use; must have a 5-year warranty; includes LED light fixtures that contain fixed LEDs within the apparatus or built into the fixture as one unit; includes automated dimmer to accommodate higher efficiency LED lighting; contract labor to install and interface dimmer controller only; *not eligible - residential grade LED lights, electrical service, wiring, conduit, keyless fixtures*
11. Ventilation fans — must be designated for poultry house ventilation use and must be fixed mounted; tunnel fans, stir fans, minimal vent fans, controllers; contract labor to install; *not eligible - belts, blades, fan cones, shrouds, diffuser guards, mounting hardware*

16. Curtains — must be designated by the manufacturer for poultry house use; sidewall drop curtains, inside divider curtains; *not eligible - labor to install*
17. Cool cell watering & ventilation systems — must be designated by the manufacturer for poultry house ventilation use; cool cell pads, cool cell pumps, sprinkler drops/spinners, controllers, pressure regulators, medicator pumps, injectors, and flush breather units specific for poultry house ventilation systems only; contract labor to install; *not eligible - nipples, water/plumbing lines, fixtures, mounting hardware*
18. Slats for hen houses — must be purchased through a poultry supply company and meet housing system specifications; preassembled plastic slats and pre-cut wooden slats, sticks and structural rail support systems; *not eligible - hardware, individual boards or lumber that is not purchased through a poultry supply store or itemized for wooden poultry slats*
19. Nesting pads for hen houses — must be designated by the manufacturer for poultry house use
20. Egg conveyor belts — conveyor belts; *not eligible - egg packers, tables, repairs*
21. Brooders and heaters — must be designated by the manufacturer for poultry house use; full section only; *not eligible - repairs, parts, labor*
22. Knee braces — must be made of metal and designated by the manufacturer for poultry house use; contract labor to install; *not eligible - repairs, parts, lags/bolts*

Guidelines

Allowable purchase dates for Swine Producer are from October 1, 2023 – August 1, 2024.

All items, regardless of backorder status, must be purchased (paid in full or financed) by the program reimbursement deadline. Backordered items may be ineligible for cost share if not delivered to the farm by the program deadline. *See p. 7 for more information regarding program requirements.*

Eligible Items

New or Used Equipment — Item 1

- Propane tank — above ground and for swine use only; must be purchased and installed by a Tennessee licensed dealer and be ASME certified (American Society of Mechanical Engineers); 1,000-gallon minimum capacity (small capacity tanks of 500 gallons may be purchased to reach the minimum capacity); concrete pad or footers; contracted labor to install; *not eligible – electrical service*

New Equipment Only — Items 2 - 14

∅ *New items cannot be previously owned.*

∅ *Items purchased at an auction are considered used and are not eligible.*

∅ *Replacement parts are not eligible.*

- Curtain — must be designated by the manufacturer for swine barn use; *not eligible – labor to install*
- Farrowing crate — commercially manufactured from swine supply company
- Farrowing crate flooring — commercially manufactured from swine supply company
- Generator — for swine production use only; must be stationary, fixed mounted; minimum of 20 KW per barn; concrete pad foundation; includes materials to connect and wire the generator; contract labor to install; *not eligible – portable/PTO generators*
- Heater — for use in gestation and nursery areas; contract labor to install; *not eligible – electrical service*
- Feed bin with optional auger and concrete foundation pad — for on farm storage of swine feed only; contract labor to install; *not eligible – replacement parts*
- Feed bin scale — automated feed bin scales and electronics; contract labor to install and interface; *not eligible – electrical service*
- Manure/lagoon agitator — for use in manure tanks and lagoon
- Manure/lagoon pump — for use in manure tanks and lagoons
- Manure spreader/injector — for liquid waste
- Nursery pen — commercially manufactured from swine supply company
- Ventilation fan — designed for swine barn ventilation use; must be fixed mounted; contract labor to install; *not eligible – belts, blades, fan cones, shrouds, diffuser guards, mounting hardware*
- Ventilation door — vents, tunnel doors, and inlets; contract labor to install; *not eligible – louvers, shutters, mounting hardware*

Frequently Asked Questions

Am I eligible to apply for TAEP?

Review TAEP's eligibility requirements on p. 6 to determine if you meet basic requirements.

How to determine if I qualify for a program?

- Review program descriptions and livestock/acreage minimum requirements to determine the programs for which you qualify. Verification of minimum requirements may be requested prior to approval.
 - Head of livestock refers to the maximum number of single type, regardless of sex or age, at any one time during the last 12 months.
 - Goats/Sheep can be combined to meet minimum head requirement.
 - Poultry growers must be commercial growers to qualify.
 - Swine producers must be commercial growers to qualify.

Do I need any certifications or permits to apply?

- Cattle producers are required to have a current BQA at time of application.
- Dairy producers must be permitted by TDA to be eligible as a dairy at time of application.
- Swine producers must be Pork Quality Assurance (PQA) Plus certified at time of application.

How to Apply?

- Applications must be submitted during the application period (October 1-7, 2023).
- Applications may be submitted by mail, online, or hand delivery only.

What are the advantages to applying online?

- Ensures all sections of the application are completed.
- Verifies application was received by sending a confirmation email.
- Efficient. Eliminates a trip to the post office to mail.

Who can apply online?

- New applicants.
- Returning applicants.

Do I need a TAEP Producer Number (TPN) to apply online?

- No, it is not necessary to have a TPN to apply online.
- New applicants will not have a TPN.
- Returning applicants can apply without listing their TPN.

Do I need a TAEP Account to apply online?

- No, a TAEP Account is not required to apply online.
- New applicants will not have a TPN and will not be able to create an account within the TAEP Account Portal.
- ***The TAEP Account Portal is separate from the online application. The application link does not exist within the TAEP Account Portal.***

What do I need to apply online?

- Access to the internet – applicant must have a functional internet connection to submit an online application.
- Electronic device – computers, laptops, and tablets are preferred over smartphones.
- Valid email address – applicant must be able to send and receive emails.

Where do I go to apply online?

- Visit www.tn.gov/taep during the application period (October 1-7, 2023).
- Click on the red "APPLY NOW – TAEP Application A" button.

How do I know my online application was submitted?

- Applicant will receive an email from taep.online@tn.gov confirming application was submitted. The confirmation email will indicate program selected.
- Check spam/junk folder if confirmation email is not received within 15 minutes of submitting application.
- Applicant is encouraged to keep a copy of email confirmation as proof of applying.

Can I change my program request after applying?

- Applicant will not be allowed to change cost share program after the application period ends (October 7, 2023).
- Review application accuracy prior to submitting. Always double check your program request and minimum requirements.

Proof of Applying

It is recommended to secure proof of applying for TAEP cost share funding. Forms of proof include:

- Paper application – copy of application and tracking receipt showing application was mailed during the application period (October 1-7, 2023).
- Online application – copy of application confirmation email from taep.online@tn.gov.

- Applications are not accepted by email, fax, or text.

Tip: Applicants are encouraged to keep a copy of their application materials and mail the original using a traceable method of delivery. For example, USPS Certified Mail with Return Receipt method will provide the sender with evidence of delivery (to whom the mail was delivered and date of delivery). It is not necessary to overnight, UPS, or FedEx application.

Online Application

Applicants may apply electrically via a live link at www.tn.gov/taep during the application period (October 1-7, 2023) by clicking on the red **“APPLY NOW – TAEP Application A”** button. The online application allows for both new and returning applicants to apply. Applying online ensures all sections of the application are complete and verifies the application was received by sending a confirmation email to the applicant. Applicant must have a valid email address to apply online.
