**ORDER ADOPTING RECEIVER’S PROPOSAL FOR LIMITED VISITATION  
AT GALILEE MEMORIAL GARDENS AND SETTING 5/17/19 DEADLINE  
FOR RECEIVER WITH RESPECT TO ATTACHED PROPOSED ORDER**

In response to the April 29, 2019 Order for the Receiver to file a memorandum on the Court’s inquiry concerning a May 2019 day to open Galilee Memorial Gardens (the “Cemetery”), the Receiver has filed an excellent and comprehensive response and alternative.

After considering and studying the *Receiver’s Memorandum on a Potential May 2019 Day of Temporary Visitation*, filed May 7, 2019, the Court finds that its inquiry to the Receiver of a one-day temporary opening of the Cemetery in May 2019 is more

expensive and not feasible with respect to the traffic and crowds of visitors than an alternative the Receiver has proposed and which has the approval and support of the Commissioner.

It is therefore ORDERED that the Court adopts the Receiver's plan for opening Galilee Memorial Gardens to the public on a predictable schedule of weekends and holidays but upon the conditions that the visitors proceed at their own risk on the uneven ground of the Cemetery, and that neither the Commissioner nor her Department, the Receiver, Receiver Management, Inc. nor the Court shall monitor or be responsible for these Cemetery visitations.

An attached Draft Order is provided for the Receiver to review and provide modifications or additions, if any, by May 17, 2019, for entry of the Order in advance of the May 25, 2019 proposed first opening day and so arrangements can proceed to open the Cemetery on May 25, 2019.
