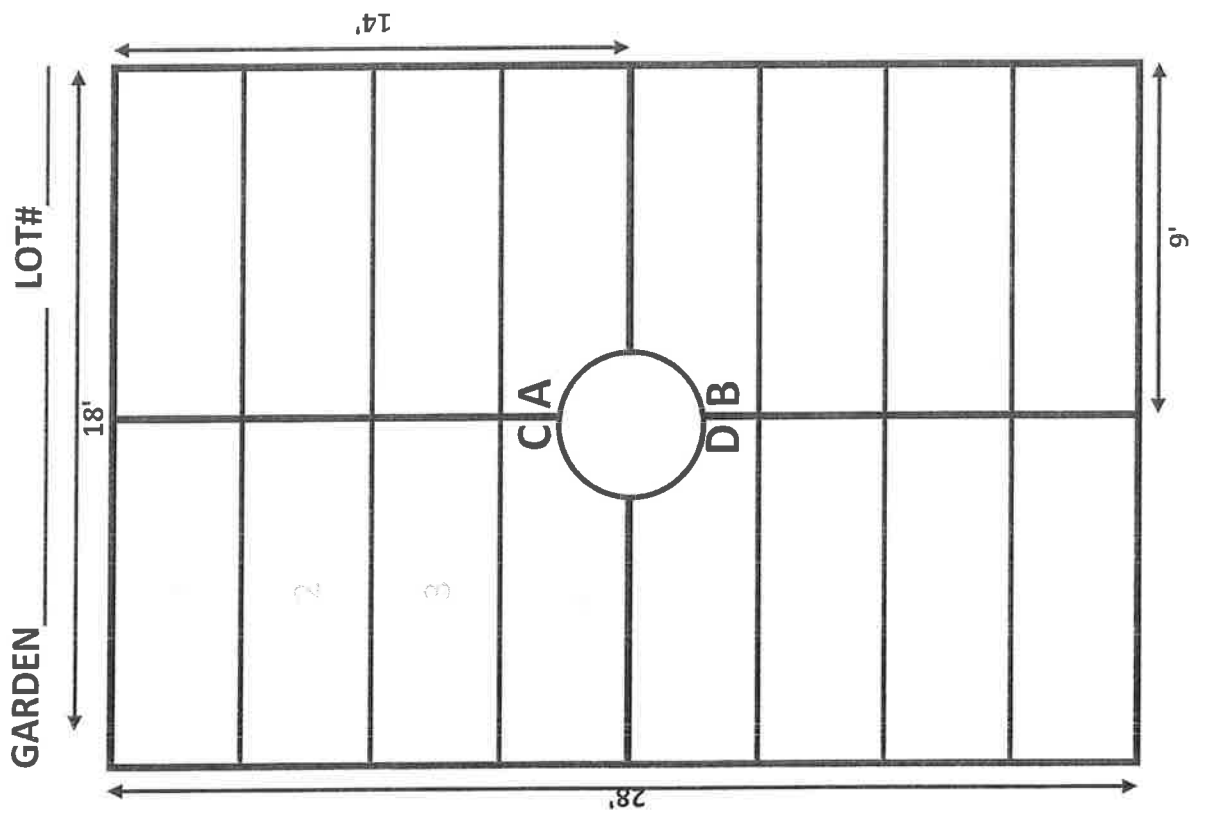
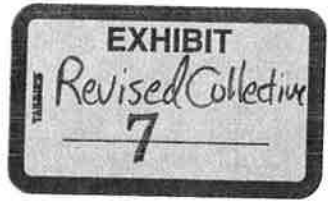
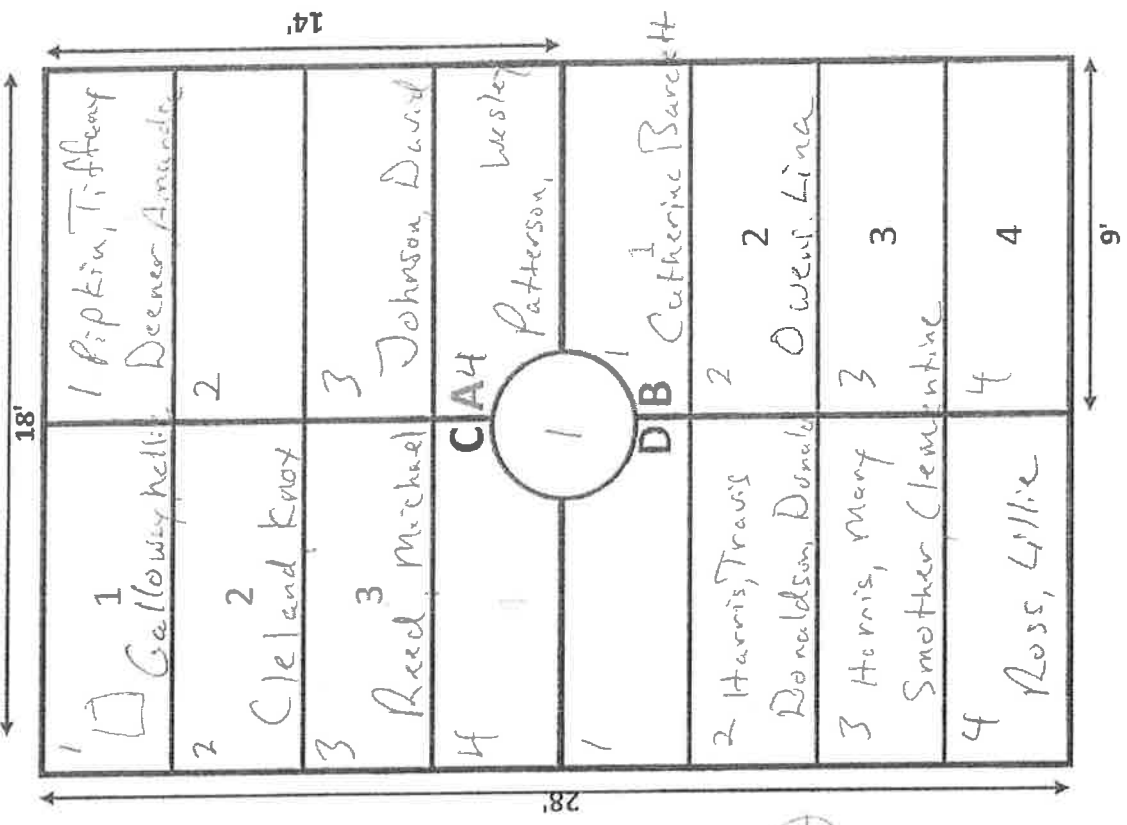

 Typical Plat

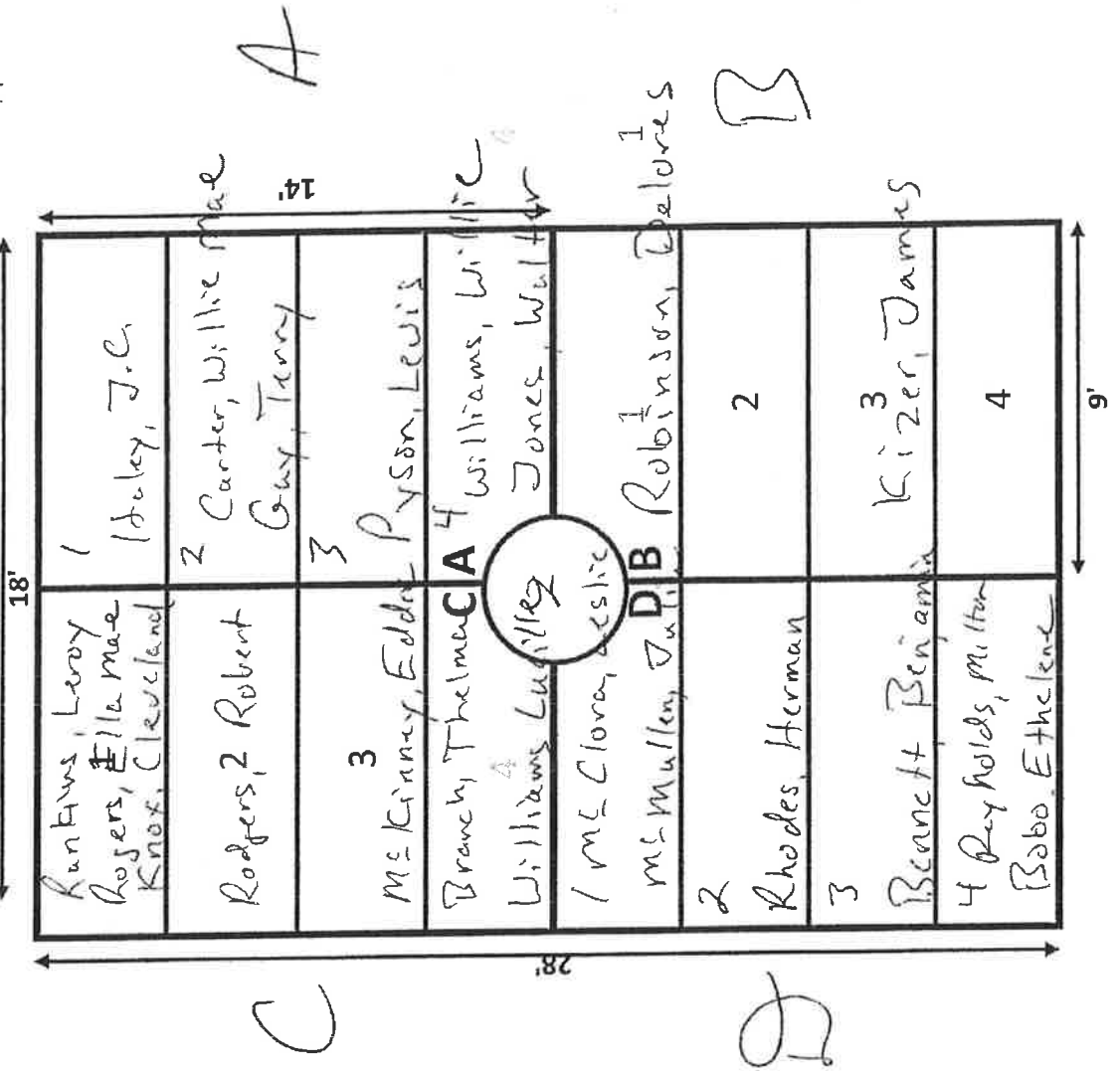

 As recorded



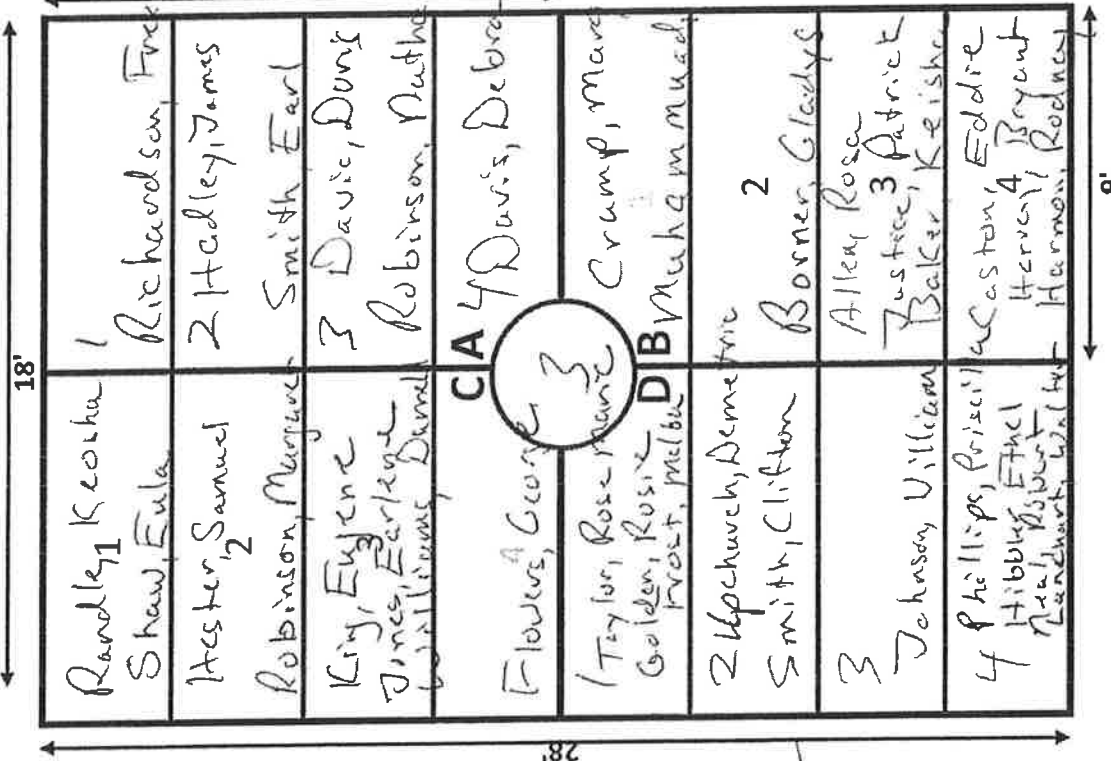
