

ORDER FOLLOWING STATUS CONFERENCE ON RECEIVERSHIP


In accordance with the Agreed Order Setting Status Conference on Receivership entered by this Court on June 24, 2016, a Status Conference was held in the above-captioned matter on August 17, 2016 to consider the Ninth Interim Report of the Special Deputy Receiver for Galilee Memorial Gardens. Following that Status Conference at which counsel for the parties appeared, the Court finds that the Ninth Interim Report is accepted, that the recommendations made by the Special Deputy Receiver in that report have been reviewed, and that at this point the Receiver has completed substantially all of the responsibilities imposed on the Receiver by statute. Accordingly, it is appropriate and hereby ORDERED that the Receiver proceed with the winding down of the receivership and to the discharge of the Receiver, those steps to be achieved through

a further hearing or hearings in this Court. The receivership order and related injunctions and stays remain in effect.

It is so ORDERED.
