I went to Pro-board conference in January. This is a financial status report for Pro-board. Pro-board has been self-sufficient for 33 yrs. They are a 501C3organization. Last year they took in \$742,000, paid out \$616,000, and have \$867,000 in their reserve balance.

They have a new online application process that can be a pilot for our online process as well starting this spring. The benefits are that you can update your application and edit also in one place.

IAFF has returned to Pro-board for recognition of its HAZMAT awareness and operations program. Free to members.

South Carolina is accredited through Pro-board.

NFPA is working on accreditation of its Inspector's program.
