

## **Assistant to the Commissioner Checklist**

This document is intended to assist you in the completion of the designation of an Assistant to the Commissioner. If you need assistance, please call (615) 350-6443.

Pursuant to Tenn. Code Ann. § 68-102-108(c), "every **person** who is or becomes an assistant pursuant to this section shall, within thirty (30) days after obtaining that status, submit to the commissioner the person's name, address, and adequate documentation to establish the person's claim of office. Upon receipt of such information, the commissioner shall issue to the officer a certificate that evidences the officer's status as an assistant." This means that the assistant to the commissioner ("ATC") certificate is non-transferable. It is issued to a specific person, <u>not</u> to a specific position (i.e. fire chief) or department.

The Assistant to the Commissioner is responsible for fire investigations, fire loss reporting within 10 days of loss, and determining if a structure damaged by fire can be repaired pursuant to <u>T.C.A.</u> §§ 68-102-111.
