**TENNESSEE MODULAR BUILDING UNIT CERTIFICATION LABELS
TO CONSTRUCTION INSPECTION AGENCY INSTRUCTIONS**

Construction Inspection Agencies (CIA) shall maintain a stock of Tennessee Modular Building Unit Certification Labels adequate to supply their clients for at least thirty (30) days.

These Tennessee Modular Building Unit Certification Labels may be ordered by submitting the Requisition for Tennessee Modular Building Unit Certification Labels Letter to this office.

All items on the form **MUST** be completed prior to mailing application. If an item does not apply, simply put **N/A** or **None** in that space. Any blank spaces will result in a delay in processing.

Labels will be shipped to the Construction Inspection Agency (CIA) accompanied by the Tennessee Modular Building Unit Certification Labels- Shipment Notification and Receipt Letter.

Upon receipt of the Tennessee Modular Building Unit Certification Labels the Construction Inspection Agency Official (CIA) must sign and return one (1) copy of the Tennessee Modular Building Unit Certification Labels- Shipment Notification and Receipt Letter to the address listed above within five (5) days from the date of receipt of shipment.
