I, Brenda Sechler, having first been duly sworn, depose and state the following:

1. I currently serve as Director of Agent Licensing for the Tennessee Insurance Division of the Department of Commerce and Insurance (hereinafter referred to as the "Division"), a position I have held for nine (9) years. I am over the age of 18 and have personal knowledge of the matters stated in this Affidavit.

2. In my position as Director of Agent Licensing, I am charged with the overseeing the licensing and renewal of insurance producer licenses in accordance with the Tennessee Insurance Law.

3. As Director of Agent Licensing, I have custody and control of all the records related to insurance producers and insurance producers license registration in the State of Tennessee.

4. At the request of the Insurance Division, I have searched the records regarding American Trade Association, LLC.

5. The search revealed that there is no record of American Trade Association, LLC as being a licensed business entity insurance producer in the State of Tennessee.

6. At the request of the Insurance Division, I have searched the records regarding American Trade Association, Inc.

7. The search revealed that there is no record of American Trade Association, Inc. as being a licensed business entity insurance producer in the State of Tennessee.

8. At the request of the Insurance Division, I have searched the records regarding Smart Data Solutions.

9. The search revealed that on January 24, 2006, Smart Data Solutions submitted the fees and an incomplete application for a license as a business entity insurance producer in the State of Tennessee. Smart Data Solutions never completed the application and was never granted an insurance producer license.

10. At the request of the Insurance Division, I have searched the records regarding Real Benefits Association.

11. The search revealed that there is no record of Real Benefits Association as being a licensed business entity insurance producer in the State of Tennessee.

12. At the request of the Insurance Division, I have searched the records regarding Obed W. Kirkpatrick, Sr.

13. The search revealed that Obed W. Kirkpatrick, Sr. had his insurance producer license revoked in February, 2007.

14. At the request of the Insurance Division, I have searched the records regarding Richard H. Bachman.

15. The search revealed that Richard H. Bachman is a current licensed insurance producer in the State of Tennessee, license numbered 900932, obtained on March 14, 2006. Bachman is licensed to sell life accident and health insurance.

16. At the request of the Insurance Division, I have searched the records regarding Bart S. Posey.

17. The search revealed that Bart S. Posey has an expired insurance producer license in the State of Tennessee, license numbered 807010, originally obtained on February 26, 1999. His license expired on March 31, 2009. Posey was licensed to sell property and accident and health insurance.

18. At the request of the Insurance Division, I have searched the records regarding William M. Worthy II.

19. The search revealed that William M. Worthy II had his insurance producer license revoked in January 2006.

20. At the request of the Insurance Division, I have searched the records regarding Angie Posey.

21. The search revealed that Angie Posey has an expired insurance producer license in the State of Tennessee, license numbered 825899, originally obtained on April 5, 2000. Her license expired on April 4, 2001. Angie Posey was licensed to sell casualty insurance.

22. At the request of the Insurance Division, I have searched the records regarding Collin Youell.

23. The search revealed that there is no record of Collin Youell as being a licensed insurance producer in the State of Tennessee.

24. At the request of the Insurance Division, I have searched the records regarding Linda Kirkpatrick.

25. The search revealed that there is no record of Linda Kirkpatrick as being a licensed insurance producer in the State of Tennessee.

26. At the request of the Insurance Division, I have searched the records regarding Kristy Wright.

27. The search revealed that on March 2, 1998 Kristy Wright applied for a license as an insurance producer in the State of Tennessee. Kristy Wright did not pass the required insurance producer licensing examination and was never granted an insurance producer license.

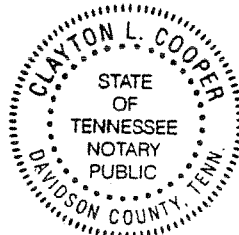
