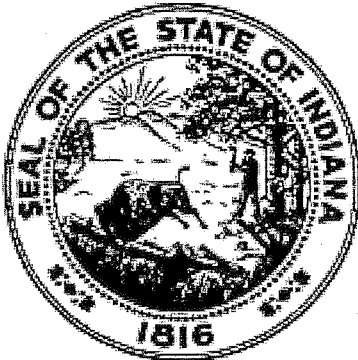

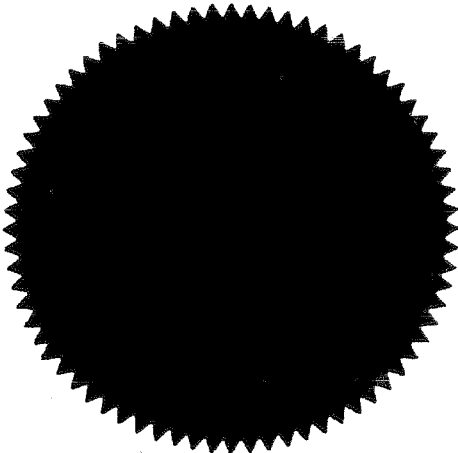

Income Distributions. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II of these Articles.

Interest of Directors in Contracts. Any contract or other transaction between the Corporation and any one or more of its directors or between the Corporation and any firm in which one or more of its directors are members, directors, officers, shareholders, or in which they are interested, shall be valid for all purposes, notwithstanding the presence of such director or directors at the meeting of the Board of Directors which acts upon or in reference to such contract or transaction and notwithstanding his, her or their participation in such action, if the fact that such interest shall be disclosed or known to the Board of Directors and the Board of Directors shall authorize, approve and ratify such contract or transaction by a vote of a majority of the directors present, such director or directors to be counted in determining whether a quorum is present, but not to be counted in calculating the majority of such quorum necessary to carry such vote. This section shall not be construed to invalidate any contract or other transaction which would otherwise be valid under the common or statutory law applicable thereto.

* Indemnification of Directors and Officers. The Corporation shall indemnify each person who is or was a director, officer, employee or agent of the Corporation, or of any other corporation which he is serving or served in any capacity at the request of the Corporation, against any and all liability and reasonable expenses that may be incurred by him in connection with or resulting from any claim, action, suit or proceeding (whether actual or threatened, brought by or in the right of the Corporation or such other corporation or otherwise, civil or criminal, administrative, investigative, or in connection with an appeal relating thereto), in which he may become involved, as a party or otherwise, by reason of being or having been in any such capacity, or arising out of his status as such, whether or not he continues to be such at the time such liability or expense is incurred; provided, that such person acted in good faith, in what he reasonably believed to be the best interests of the Corporation or such other corporation, as the case may be, and, in addition, in any criminal action or proceedings, had no reasonable cause to believe that his conduct was unlawful. As used in these powers, the terms "liability" and "expense" shall include, but shall not be limited to, attorneys' fees and disbursements and amounts of judgments, fines or penalties against the amounts paid in settlement. Determination of any claim, action, suit or proceeding, civil or criminal, by judgment, settlement (whether with or without court approval) or conviction or upon a plea of guilty or of nolo contendere, or its equivalent, shall not create a presumption that a director, employee, agent or officer did not meet the standards of conduct set forth in the first sentence of this Section.

If several claims, issues or matters of action are involved, any such person may be entitled to indemnification as to some matters even though he is not so entitled as to others. The Corporation may advance expenses to, or where appropriate may at its expense undertake defense of, any such person upon receipt of an undertaking by or on behalf of such person to repay such expenses

if it should ultimately be determined that he is not entitled to indemnification under this Section.

Any director, officer, employee or agent who has been wholly successful, on the merits or otherwise, with respect to any claim, suit or proceeding of the character described herein shall be entitled to indemnification as of right. Except as provided in the preceding sentence, any indemnification hereunder shall be made at the discretion of the Corporation, but only if (1) the Board of Directors, acting by a quorum consisting of directors who are not parties to or who had been wholly successful with respect to such claim, action, suit or proceeding, shall find that the director, officer, employee or agent has met the standards of conduct set forth in the first sentence of this Section; or (2) independent legal counsel (who may be regular counsel of the Corporation) shall deliver to it their written opinion that such director, employee, agent or officer has met such standards.

The rights of indemnification provided hereunder shall be in addition to any rights to which any person concerned may otherwise be entitled by contract or as a matter of law, and shall inure to the benefit of the heirs and personal representatives of any such person.

Authorization to Purchase Insurance. The Board of Directors may, at its discretion, authorize the purchase by the Corporation at its expense of a policy or policies of insurance insuring the Corporation and/or any person who is or was an officer, director, employee or agent thereof, or who is or was acting at the Corporation's request in such capacity, against expense, liability, or other obligation incurred, arising out of the fact that such person or his testator or intestate was at any time or is a director, officer, employee or agent of the Corporation, or serves or served any other enterprise at the request of the Corporation. Such policy or policies shall contain such terms and conditions as the Board may deem appropriate, and may include provisions for the direct indemnification of such persons and for expenses or liabilities of a kind not specifically covered by Section 3 of this Article.
