ORDER GRANTING ANLIR RECEIVER'S JULY 13, 2012 MOTION TO ACCEPT AND ADD ADDITIONAL CLASS 2 CLAIMS TO LISTINGS APPROVED FOR INTERIM DISTRIBUTION AND FOR CORRECTION OF EARLIER SUBMITTED MATTERS

On July 13, 2012, the ANLIR Special Deputy Receiver (along with the Special Deputy Receivers for DIR and TRA) filed a Joint Motion requesting that additional Class 2 Claims be approved for the interim distribution payments established in the Court's previous November 9, 2011 Order Approving Allocation and Interim Distribution. ANLIR's July 13, 2012 Motion was set for hearing on July 27, 2012 and there was no response or opposition filed in relation to the Motion, nor was there any appearance in opposition to the Motion. All parties interested in the relief sought in the ANLIR July 13, 2012 Motion were given notice of the Motion via Certificate of Service First Class Mailing of a copy of the Motion. On July 25, 2012, ANLIR filed a Notice of Correction and Addition of Claim regarding the withdrawal of one claim from and the addition of one claim to the listing of claims for which approval of interim payment was sought.

Having reviewed the July 13, 2012 Motion and ANLIR's July 25, 2012 Notice of Correction and Addition of Claim, the Court hereby finds said Motion well-taken and grants the relief requested.


Accordingly, the Court accepts and approves for interim distribution payment the additional claims against the ANLIR Receivership Estate listed in Exhibit 1 attached hereto, which includes the additional claim noticed and excludes the erroneously stated claim as set forth in ANLIR's July 25, 2012 Notice of Correction and Addition of Claim. Moreover, pursuant to Rule 60 Tenn. R. Civ. P. and also pursuant to the equitable powers of the Court, the Court also approves the correction requested by the ANLIR Receiver in the July 13, 2012 Motion. Accordingly, and nunc pro tunc November 9, 2011, the Court accepts and approves for interim distribution payment of POC #002163 at the approved amount of \$40,500.00.¹

In the ANLIR Receivership's July 13, 2012 Motion, the request is made to enter this Order as a Final Order with regards to all matters covered herein. Rule 54.02 Tenn. R. Civ. P. As noted previously, appropriate notice was given and no opposition -- through filing or appearance -- was made to the July 13, 2012 Motion. The Court finds that this Order does not address all matters involved in the ANLIR Receivership action. The Court further finds that the ANLIR Receivership will rely upon the rulings contained in this Order in making interim distributions and the claimants will rely upon those rulings in receiving the interim distributions. Therefore, certainty as to the Court's rulings is needed. For those reasons, and there being no just reason for delay, the Court expressly instructs the Clerk and Master to enter this Order as a Final Order as to all matters contained herein. Rule 54.02 Tenn. R. Civ. P.


