FINAL AGREED JUDGMENT

This cause was scheduled to be heard on November 19, 2012, at 9:00 A.M., before The Honorable Kim Summers, Administrative Judge, and the Commissioner's Designee, Chlora Lindley-Myers, at which time the parties announced to the Court that they had reached the following agreement in this matter:

1. The Motion to Amend Caption filed by American Zurich Insurance Company ("Zurich") is hereby granted, and the caption is amended to reflect that the insurer who lodged this appeal is Mark Hoskins d/b/a Cam Com Communications ("Mr. Hoskins") and the insurers who are defending the appeal are Zurich and Companion Property and Casualty Group. Travelers Property Casualty Company of America is not a party to this administrative appeal; and,

2. Judgment shall enter in favor of American Zurich Insurance Company and against Mark Hoskins d/b/a Cam Com Communications in the amount of \$30,000.00. However, in the event that Mr. Hoskins provides payment in the total amount of \$20,000.00 to Zurich with payments being made in the amount of \$5,000.00 upon execution of this Judgment by Mr. Hoskins and three regular monthly installment payments being made in the amount of \$5,000.00 each on December 3, 2012, January 2, 2013 and February 1, 2013, this Agreed Judgment shall be satisfied and this cause dismissed with prejudice as it regards Zurich and Mr. Hoskins. A grace period of five (5) regular days shall be afforded Mr. Hoskins for any of the monthly installment



Upon consideration of the proposed Final Agreed Judgment submitted by and through counsel for the parties, the record, and for good cause appearing,



In the event that Mr. Hoskins fails to comply with these payment provisions, including failing to make a monthly payment before the aforementioned grace period, Mr. Hoskins's appeal of Zurich's premium audit determination related to Policy No. 6ZZUB-4365P59-7-10 from August 23, 2010, until August 23, 2011, will be dismissed with prejudice, and Zurich may thereafter seek and obtain execution upon the Agreed Judgment amount in its entirety together with interest thereon at the judgment rate from and after February 1, 2013, attorney's fees, discretionary costs as defined by the Tennessee Rules of Civil Procedure, and any additional court and/or appellate costs.

Costs of this appeal are taxed against Mr. Hoskins, for which execution may issue, if necessary. The Court is pleased that the parties have reached the foregoing agreement and will enter the same as this Court's Order.


