ORDER GRANTING DIR RECEIVER'S JULY 13, 2012 MOTION TO ACCEPT AND ADD ADDITIONAL CLASS 2 CLAIMS TO LISTINGS APPROVED FOR INTERIM DISTRIBUTION AND FOR CORRECTION OF EARLIER SUBMITTED MATTERS

On July 13, 2012, the DIR Special Deputy Receiver (along with the Special Deputy Receivers for ANLIR and TRA) filed a Joint Motion requesting that additional Class 2 Claims be approved for the interim distribution payments established in the Court's previous November 9, 2011 Order Approving Allocation and Interim Distribution. DIR's July 13, 2012 Motion was set for hearing on July 27, 2012 and there was no response or opposition filed in relation to the Motion, nor was there any appearance in opposition to the Motion. All parties interested in the relief sought in the DIR July 13, 2012 Motion were given notice of the Motion via Certificate of Service First Class Mailing of a copy of the Motion. On July 24, 2012, DIR filed a Notice of Correction regarding the withdrawal of three claims from the listing of claims for which approval of interim payment was sought.

Having reviewed the July 13, 2012 Motion, and DIR's July 24, 2012 Notice of Correction, the Court hereby finds said Motion well-taken and grants the relief requested.

Accordingly, the Court accepts and approves for interim distribution payment the additional claims against the DIR Receivership Estate listed in Exhibit 1 attached hereto.¹

Moreover pursuant to Rule 60 Tenn. R. Civ. P. and also pursuant to the equitable powers of the Court, the Court approves the two corrections requested by the DIR Receiver in the July 13, 2012 Motion: (1) DIR POC #002611, as corrected to the amount of \$6,767.64, is accepted and approved for interim distribution payment - - and appears as part of Exhibit 1 hereto, and (2) the listing of DIR POC #0001178 in the Court's previous February 13, 2012 Order is stricken.

As to payment of the interim distribution on the additional claims listed in Exhibit 1, the Court orders -- as was ordered in its previous November 9, 2011 Order Approving Allocation and Interim Distribution -- that the DIR Receivership may delay payment of the interim distribution until appropriate information is provided by the particular claimant regarding any Medicare/Medicaid lien and/or adequate assurances are received by the DIR Receivership that no such lien(s) exists (e.g. CMS waivers, etc.) or that interim distribution payments do not otherwise implicate or violate the Medicare/Medicaid lien laws.²

In the July 13, 2012 Motion, the request is made to enter this Order as a Final Order with regards to all matters covered herein. Rule 54.02 Tenn. R. Civ. P. As noted previously, appropriate notice was given and no opposition -- through filing or appearance -- was made to the July 13, 2012 Motion. The Court finds that this Order does not address all matters involved in the DIR Receivership action. The Court further finds that the DIR Receivership will rely upon the rulings contained in this Order in making interim distributions and the claimants will rely upon those rulings in receiving the interim distributions. Therefore, certainty as to the Court's rulings is needed. For

those reasons, and there being no just reason for delay, the Court expressly instructs the Clerk and Master to enter this Order as a Final Order as to all matters contained herein. Rule 54.02 Tenn. R. Civ. P.

Given the lack of objection to the DIR July 13, 2012 Motion, the Court further orders that it is sufficient notice to post a copy of this Order on the Tennessee Department of Commerce and Insurance website, as has been done with previous filings and orders in this Receivership proceeding.
