**DOCTORS INSURANCE RECIPROCAL RECEIVER'S MOTION FOR THE COURT
TO ACCEPT AND APPROVE NUMEROUS CLASS 5 CLAIMS**

I. Introduction

Julie Mix McPeak, as Commissioner of the Tennessee Department of Commerce and Insurance, in her capacity as Liquidator of Doctors Insurance Reciprocal (RRG) in Liquidation ("DIR"), and through her appointed Special Deputy Receiver, moves the Court, under T.C.A. §56-9-331, to accept and approve as final the Class 5 claims set forth in **Exhibit A**. This Motion does not request approval of a distribution, pro rata or otherwise, as to the approved Class 5 claim amounts set forth in **Exhibit A**, but rather seeks approval of the listed Class 5 claims, and the respective claim amounts presented, so that they will be established and ready for distribution upon later motion to, and order of, the Court.

II. Discussion

a) Existence of One Remaining Class 2 Claim

Presently, there is one DIR Class 2 claim that has not been liquidated and has not been presented to the Court for approval or for disposition otherwise - - POC #2921 submitted by a Dr. Michael Wheelis. This Motion, again, does not request approval of a distribution or payment to any Class 5 claimant, so acknowledgment of any outstanding Class 2 claim is, perhaps, not needed. But the DIR Receiver wants the Court to know that if distributions are later requested as to Class 5 claims, the one pending DIR Class 2 claim will be appropriately addressed prior to any Class 5 claim distribution.

b) Class 5 Claims Set Forth in Exhibit A

Not all of the Class 5 claims submitted in the DIR Liquidation Proceedings are included in **Exhibit A**. For example, the Virginia Deputy Receiver, on behalf of Reciprocal of America, The Reciprocal Group and The Premium Company of America, has lodged in the DIR Liquidation Proceedings five (5) separate Class 5 claims that are not set forth in **Exhibit A**. On March 17, 2015, the DIR Special Deputy Receiver issued revised notices of determination regarding those five (5) Class 5 claims. The Virginia Deputy Receiver has responded through letter objections, dated April 14, 2015, which will be supplemented on or before July 31, 2015. Disposition of those five (5) Class 5 claims will be addressed in due course consistent with the objections lodged as to the revised notices of determination or other discussions with the Virginia Deputy Receiver. Therefore, any disposition of, and ultimate report upon, the remaining Class 5 claims in the DIR Liquidation Proceedings will be in the future. But the Class 5 claims set forth in **Exhibit A** are claims that have been reviewed and adjudicated with final recommended claim amounts (which at times are \$0.00) set forth. The DIR Receiver urges the Court to accept this report of final claim amounts, and to approve the determined claim amounts

for the Class 5 claims in **Exhibit A**. Such acceptance and approval will advance these proceedings - - all that will remain concerning the attached Class 5 claims will be a request for payment/ distribution, pro rata or otherwise, upon final disposition of the remaining Class 5 claims.

The Class 5 claims set forth in **Exhibit A** are claims that have been reviewed and had determinations issue from the DIR Special Deputy Receiver. Those determinations have either not been objected to (and thus are final) or have been objected to with the objection addressed to final disposition. Accordingly, they are ripe to be presented as the final claim amounts for the listed Class 5 claims. Pursuant to T.C.A. §56-9-331, the DIR Receiver recommends that the Court accept this report as to the Class 5 claims set forth in **Exhibit A** and approve the final claim amounts listed for these claims.

III. Notice

Notice of this Motion will be given to every Class 5 claimant of the DIR Liquidation Estate. Every such claimant will have a postcard sent to him/her/it at each claimant's address as shown in the DIR Liquidation's records. That postcard notice will inform the claimant of the filing of this motion, the hearing date, time and place, the deadline for response to the motion, a short description of the relief sought in the motion and a reference to the Tennessee Department of Commerce and Insurance website where a complete copy of this Motion and exhibits will be posted. Attached as **Exhibit B** is a template of that "postcard" notice.

Notice will be provided to the Virginia Deputy Receiver through mailing a copy of this Motion and exhibits to counsel. Notice will be provided to Dr. Wheelis (the sole remaining Class 2 DIR claimant with an unresolved Class 2 claim) through mailing a copy of this Motion and exhibits to counsel for Dr. Wheelis. Because the other DIR Class 2 claims and the Class 3 and 4 claims (if any) have already been finalized and paid, no notice will be provided to them of

this Motion. A copy of the Motion and exhibits attached hereto will be posted on the Tennessee Department of Commerce and Insurance website as soon as practicable after the filing of this Motion.


IV. Request That Order Granting Requested Relief Be Made Final Pursuant to Rule 54.02 Tenn. R. Civ. P.

This Motion seeks relief that needs to be relied upon in advancing the progression of the DIR Liquidation Proceedings toward further distributions and ultimate closure. But the relief afforded through granting this Motion does not address all matters at issue in the DIR Liquidation Proceedings. In order to provide certainty with regard to the relief granted, the DIR Receiver requests that the Court expressly find that there exists no just reason for delay and that the Order granting this Motion be entered as final regarding the matters addressed in that Order. Rule 54.02 Tenn. R. Civ. P.

V. Conclusion

For the reasons set forth herein, the DIR Receiver requests this Court, pursuant to T.C.A. §56-9-331, (1) accept **Exhibit A** attached hereto as a report and listing of certain Class 5 claims, (2) approve the claim amounts set forth in **Exhibit A** for each such Class 5 claim and (3) incorporate those listings in a final order granting the relief requested herein.

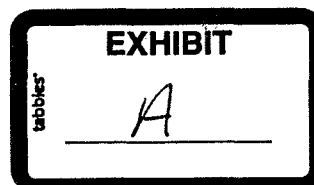
