**NOTICE OF RECEIVER'S SUPPLEMENTATION OF LISTINGS OF CLASS 2  
CLAIMS PROPOSED TO BE PAID IN INTERIM DISTRIBUTION**

On October 5, 2011, the Receiver of American National Lawyers Insurance Reciprocal (RRG) in Liquidation ("ANLIR"), Doctors Insurance Reciprocal (RRG) in Liquidation ("DIR") and The Reciprocal Alliance (RRG) in Liquidation ("TRA"), by and through her appointed Special Deputy Receivers, filed with the Court a motion that:

- 1) sets forth the Receiver's proposal to allocate joint recoveries amongst the three RRG Receivership Estates;
