~~PROPOSED~~ ORDER ACCEPTING AND APPROVING NUMEROUS FINAL DETERMINATIONS AS TO ENUMERATED CLAIMS IN THE RECIPROCAL ALLIANCE, RRG LIQUIDATION ESTATE *RTT*

---

Before this Court is a Motion filed on December 3, 2015 by the Commissioner of the Tennessee Department of Commerce and Insurance, in her capacity as Liquidator of The Reciprocal Alliance (RRG) in Liquidation ("TRA"), through her appointed Special Deputy Receiver. The Motion requests the Court accept and approve the determination of numerous Class 6 and Class 7 claims submitted in the TRA Liquidation proceedings. Attached as **Exhibit A** to this Order is the listing of finalized Class 6 claim determinations for which acceptance and approval are sought and attached as **Exhibit B** to this Order is the listing of finalized Class 7 claim determinations for which acceptance and approval are sought. From TRA's pending Motion, the Court understands that while acceptance and approval of the Class 6 and Class 7 claims set forth in **Exhibit A** and **Exhibit B** are sought, the Commissioner / TRA Special Deputy Receiver do not seek approval of any payment of those approved claim amounts, pro rata or

otherwise. Any payment, pro rata or otherwise, of those listed claim amounts will occur only upon further motion to, and order of, the Court.

There have been no objections or oppositions filed in relation to the pending Motion. Upon review of the Motion and upon the record in this proceeding as a whole, the Court finds the Motion well taken.


Accordingly, the Court approves the Class 6 claim amounts listed in **Exhibit A** to this Order in the column entitled "RRAO Determined Value" which aggregates to the amount of \$73,457.51. The Court also acknowledges and accepts the listings set forth in **Exhibit A** to this Order as the TRA Liquidator's report of those Class 6 claims which are final. T.C.A. §56-9-331. The Court approves the Class 7 claim amounts listed in **Exhibit B** to this Order in the column entitled "RRAO Determined Value" which aggregates to the amount of \$51,712.34. The Court also acknowledges and accepts the listings set forth in **Exhibit B** to this Order as TRA Liquidator's report of those Class 7 claims which are final. T.C.A. §56-9-331. Distribution or payment, pro rata or otherwise, of these listed Class 6 and Class 7 claims will await further order of this Court.

In their December 3, 2015 Motion, the Commissioner and TRA Special Deputy Receiver request, pursuant to Rule 54.02 Tenn. R. Civ. P., that the Order entered in relation to the pending Motion be entered as a final order in relation to all matters addressed herein. The Court finds that this Order does not address all matters involved in the TRA liquidation proceeding. The Court further finds that the TRA Special Deputy Receiver will rely upon the rulings contained in this Order in taking actions such as ultimate payment, pro rata or otherwise, of the Class 6 and Class 7 claims approved herein. In doing so, the TRA Liquidation Estate needs certainty as to the Court's rulings. For that reason, and there being no just reason for delay, the Court expressly

instructs the Clerk and Master to enter this Order as a final Order as to all matters contained herein. Rule 54.02 Tenn. R. Civ. P






