**ORDER ADOPTING EXAMINATION REPORT**

Code Ann. §§ 56-1-401, *et seq.*, the Insurance Division of the State of Tennessee Department of Commerce and Insurance (“Division”) has examined certain affairs of American General Life and Accident Insurance Company (“Company”), an insurance company domiciled in the State of Tennessee. As a result of an examination conducted as of the 31<sup>st</sup> day of December, 2006, the examiner-in-charge filed with the Division, on the 2<sup>nd</sup> day of June, 2008, a verified, written report on the examination, and a copy of that report has been sent to American General Life and Accident Insurance Company (The Report on Examination of American General Life and Accident Insurance Company is attached hereto as Exhibit A). The Division received no written rebuttal to said examination report from the Company.

Pursuant to Tenn. Code Ann. § 56-1-411, said examination report regarding the affairs of American General Life and Accident Insurance Company filed with the Insurance Division of the State of Tennessee Department of Commerce and Insurance on the 2<sup>nd</sup> day of June, 2008, is hereby **ADOPTED** as filed.

The adoption of this examination report shall not preclude the Department from imposing sanctions against American General Life and Accident Insurance Company for potential violations of the Tennessee Insurance Law which may be revealed in the examination report, it being the intent of this Order Adopting Examination Report merely to adopt the examination

report filed by the examiner-in-charge.
