(hereinafter also referred to as the "Company"), an insurance company domiciled in the State of Tennessee. As a result of an examination conducted as of the 31<sup>st</sup> day of December, 2005, the examiner-in-charge filed with the Division, on the 27<sup>th</sup> day of October, 2006, a verified, written report on the examination, and a copy of that report has been sent to Aetna Health, Inc.
