ORDER ADOPTING EXAMINATION REPORT WITH DIRECTIVES

Pursuant to Tenn. Code Ann. § 56-32-215 the Insurance Division of the State of Tennessee Department of Commerce and Insurance (hereinafter referred to as the "Division") has examined certain affairs of Cariten Health Plan, Inc. (hereinafter also referred to as the "Company"), an insurance company domiciled in the State of Tennessee. As a result of an examination conducted as of the 31st day of December, 2005, the examiner-in-charge filed with the Division, on the 11th day of June, 2007, a verified, written report on examination, and a copy of that report has been sent to the Company. (The Report on Examination of Cariten Health Plan, Inc. is attached hereto and marked as Exhibit A). The Division received a written rebuttal to said examination report from the Company on June 26, 2007. (The written rebuttal is attached hereto and marked as Exhibit B).

Pursuant to Tenn. Code Ann. § 56-1-411, said examination report regarding the affairs of the Company, filed with the Division the 11th day of June, 2007, is hereby **ADOPTED** as filed with the following **DIRECTIVES**:

1. The Company is **DIRECTED** to comply Tenn. Code Ann. § 56-32-210(c)(5) by implementing a consistent system for responding to all grievances that complies with said rule.
2. The Company is **DIRECTED** to comply with Tenn. Code Ann. § 56-32-203(b)(4) and (c)(1) by updating its HMO's Physicians' Manual and the provider contracts.


3. The Company is **DIRECTED** to comply with Tenn. Code Ann. § 56-32-211 and Tenn. Code Ann. § 56-3-408(b)(1) to ensure no investment or loan is made without authorization by the Board of Directors or a committee appointed by the Board of Directors to supervise such investments or loans.

The company shall comply with the directives contained in this order within thirty (30) days of its entry.

The adoption of this examination report shall not preclude the Department from imposing sanctions against the Company for potential violations of the Tennessee Insurance Law which may be revealed in the examination report, it being the intent of this Order Adopting Examination Report with Directives merely to adopt the examination report filed by the examiner-in-charge.




