ORDER ADOPTING EXAMINATION REPORT

Pursuant to Tenn. Code Ann. §§ 56-1-401, *et seq.*, the Insurance Division of the State of Tennessee Department of Commerce and Insurance (hereinafter referred to as the "Division") has examined certain affairs of Cariten Health Plan, Inc., (hereinafter also referred to as the "Company"), a health maintenance organization domiciled in the state of Tennessee. As a result of an examination conducted as of the 31st day of December, 2009, the insurance examiner filed with the Division, on the 24th day of June, 2011, a verified, written report on the examination, and a copy of that report has been sent to the Company. (The Report on Examination of Cariten Health Plan, Inc., is attached hereto and marked as Exhibit A). The Company has waived all review rights it may have with respect to the examination report, pursuant to Tenn. Code Ann. § 56-1-411(d)(1). The Division received no written rebuttal to said examination report from the Company.

Pursuant to Tenn. Code Ann. § 56-1-411, said examination report regarding the affairs of Cariten Health Plan, Inc., filed with the Insurance Division of the State of Tennessee Department of Commerce and Insurance on the 24th day of June, 2011, is hereby **ADOPTED** as filed.

The adoption of this examination report shall not preclude the Department from imposing sanctions against Cariten Health Plan, Inc., for potential violations of the Tennessee Insurance Law which may be revealed in the examination report, it being the intent of this Order Adopting Examination Report merely to adopt the examination report filed by the examiner-in-charge.
