ORDER ADOPTING EXAMINATION REPORT

Pursuant to Tenn. Code Ann. §§ 56-1-401, *et seq.* and 56-32-115(b), the Insurance Division of the State of Tennessee Department of Commerce and Insurance (hereinafter referred to as the "Division") has examined certain affairs of Erlanger Health Plan Trust (hereinafter referred to as the "Company"), a health maintenance organization domiciled in the state of Tennessee. As a result of an examination conducted as of the 31<sup>st</sup> day of December, 2011, the insurance examiner filed with the Division, on the 6<sup>th</sup> day of September, 2012, a verified, written report on the examination, and a copy of that report has been sent to the Company. (The Report on Examination of Erlanger Health Plan Trust is attached hereto and marked as Exhibit A). The Division received no written rebuttal to said examination report from the Company.

Pursuant to Tenn. Code Ann. §§ 56-1-411 and 56-32-115(b), said examination report regarding the affairs of Erlanger Health Plan Trust which was filed with the Insurance Division of the State of Tennessee Department of Commerce and Insurance on the 6<sup>th</sup> day of September 2012, is hereby **ADOPTED** as filed.

The adoption of this examination report shall not preclude the Department from imposing sanctions against Erlanger Health Plan Trust for potential violations of the Tennessee Insurance Law which may be revealed in the examination report, it being the intent of this Order Adopting Examination Report merely to adopt the examination report filed by the examiner-in-charge.
