Code Ann. § 56-22-101 *et seq.*, the Insurance Division of the State of Tennessee Department of Commerce and Insurance (“Division”) has examined certain affairs of Farmers Aid Association of Loudon County (“Company”), a county mutual insurance company domiciled in the state of Tennessee. As a result of an examination conducted as of the 31<sup>st</sup> day of December 2011, the insurance examiner filed with the Division, on the 6<sup>th</sup> day of March 2013, a verified, written report on the examination, and a copy of that report has been sent to the Company. The Division received a written response letter to said examination report from the Company on April 10, 2013. (The Company’s response letter is attached hereto and marked as Exhibit B.)

Pursuant to Tenn. Code Ann. § 56-22-115, said examination report regarding the affairs of the Company, filed with the Division on the 6<sup>th</sup> day of March 2013, is hereby **ADOPTED** as filed.

The adoption of this examination report shall not preclude the Department from imposing sanctions against the Company for potential violations of the Tennessee Insurance Law which may be revealed in the examination report, it being the intent of this Order Adopting


Examination Report merely to adopt the examination report filed by the examiner-in-charge.


