ORDER ADOPTING EXAMINATION REPORT

Code Ann. §§ 56-1-401 *et seq.*, the Insurance Division of the State of Tennessee Department of Commerce and Insurance (“Division”) has examined certain affairs of Farmers Mutual Fire Insurance Company of Washington County (“Company”) a mutual insurance company domiciled in the state of Tennessee. As a result of an examination conducted as of the 31st day of December 2011, the insurance examiner filed with the Division, on the 2nd day of May 2013, a verified, written report on the examination, and a copy of that report has been sent to the Company. (The Report on Examination of Farmers Mutual Fire Insurance Company of Washington County is attached hereto and marked as Exhibit A.) The Division received no written rebuttal to said examination report from the Company.

Pursuant to Tenn. Code Ann. § 56-1-411, said examination report regarding the affairs of Farmers Mutual Fire Insurance Company of Washington County, filed with the Insurance Division of the State of Tennessee Department of Commerce and Insurance on the 2nd day of May 2013, is hereby **ADOPTED** as filed.

The adoption of this examination report shall not preclude the Department from imposing sanctions against Farmers Mutual Fire Insurance Company of Washington County for potential violations of the Tennessee Insurance Law which may be revealed in the examination report, it being the intent of this Order Adopting Examination Report merely to adopt the

examination report filed by the examiner-in-charge.


