ORDER ADOPTING EXAMINATION REPORT

Code Ann. §§ 56-1-401, *et seq.*, the Insurance Division of the State of Tennessee Department of Commerce and Insurance (hereinafter referred to as the "Division") has examined certain affairs of Road Contractors Mutual Insurance Company, (hereinafter also referred to as the "Company"), a mutual insurance company domiciled in the state of Tennessee. As a result of an examination conducted as of the 30th day of September, 2011, the insurance examiner filed with the Division, on the 25th day of February, 2013, a verified, written report on the examination, and a copy of that report has been sent to the Company. (The Report on Examination of Road Contractors Mutual Insurance Company is attached hereto and marked as Exhibit A). The Division received no written rebuttal to said examination report from the Company.
