ORDER ADOPTING EXAMINATION REPORT

Code Ann. §§ 56-1-401, *et seq.*, the Insurance Division of the State of Tennessee Department of Commerce and Insurance (hereinafter referred to as the "Division") has examined certain affairs of SilverScript Insurance Company (hereinafter also referred to as the "Company"), an insurance company domiciled in the State of Tennessee. As a result of an examination conducted as of the 30th day of November, 2005, the examiner-in-charge filed with the Division, on the 4th day of May, 2006, a verified, written report on examination, and a copy of that report has been sent to SilverScript Insurance Company. (The Organizational Examination of the SilverScript Insurance Company is attached hereto and marked as Exhibit A). The Division received no written rebuttal to said examination report from the Company.
