ORDER ADOPTING EXAMINATION REPORT

Code Ann. § 56-1-401 *et seq.*, the Insurance Division of the State of Tennessee Department of Commerce and Insurance (“Division”) has examined certain affairs of TD Consortium Benefits Trust (“Trust”), an insurance company domiciled in the State of Tennessee. As a result of an examination conducted as of December 31, 2016, the examiner-in-charge filed with the Division, on February 22, 2017, a verified, written report on the examination, and a copy of that report has been sent to the Trust. (The Report on Examination of TD Consortium Benefits Trust is attached hereto and marked as Exhibit A.) The Division received a response regarding the report from the Trust on February 22, 2017. (The written response submitted by the Trust is attached hereto and marked as Exhibit B.)


Pursuant to Tenn. Code Ann. § 56-1-411, the examination report regarding the affairs of TD Consortium Benefits Trust filed with the Insurance Division of the State of Tennessee Department of Commerce and Insurance on the day of February 22, 2017, is hereby **ADOPTED** as filed.

The adoption of this examination report shall not preclude the Department from imposing sanctions against TD Consortium Benefits Trust for potential violations of the Tennessee Insurance Law which may be revealed in the examination report, it being the intent of this Order

Adopting Examination Report merely to adopt the examination report filed by the examiner-in-charge.




