ORDER ADOPTING EXAMINATION REPORT

Pursuant to Tenn. Code Ann. §§ 56-1-401, *et seq.*, the Insurance Division of the State of Tennessee Department of Commerce and Insurance (hereinafter referred to as the "Division") has examined certain affairs of the Tennessee Insurance Guaranty Association (hereinafter also referred to as the "Association"), an insurance guaranty association domiciled in the State of Tennessee. As a result of an examination conducted as of the 31st day of December, 2006, the examiner-in-charge filed with the Division, on the 19th day of May, 2008, a verified, written report on the examination, and a copy of that report has been sent to the Tennessee Insurance Guaranty Association. (The Report on Examination of the Tennessee Insurance Guarantee Association is attached hereto and marked as Exhibit A). The Division received no written rebuttal to said examination report from the Company. In a letter dated June 10, 2008, the Tennessee Insurance Guarantee Association waived any right to rebuttal with respect to the Report on Examination of the Tennessee Insurance Guarantee Association filed with the Division, on the 19th day of May, 2008. (The letter waiving rebuttal is attached hereto and marked as Exhibit B.)

Pursuant to Tenn. Code Ann. § 56-1-411, said examination report regarding the affairs of the Tennessee Insurance Guarantee Association, filed with the Insurance Division of the State of Tennessee Department of Commerce and Insurance on the 19th day of May, 2008, is hereby **ADOPTED** as filed.


