ORDER ADOPTING EXAMINATION REPORT

Pursuant to Tenn. Code Ann. § 56-12-214, the Insurance Division of the State of Tennessee, Department of Commerce and Insurance (“Division”) has examined certain affairs of Tennessee Life and Health Insurance Guaranty Association (“Association”), a nonprofit guaranty association domiciled in the state of Tennessee. As a result of an examination conducted as of December 31, 2023, the examiner-in-charge filed a verified, written report on the examination with the Division on March 21, 2025. A copy of that report was sent to the Association. (The Report on Examination of the Association is attached hereto and marked as Exhibit A).

The Division received a response regarding the report from the Association dated June 2, 2025. (The written response submitted by the Association is attached hereto and marked as Exhibit B).

Pursuant to Tenn. Code Ann. § 56-12-214, the examination report regarding the affairs of the Association is hereby **ADOPTED** as filed.

The adoption of this examination report shall not preclude the Department from imposing sanctions against the Association for potential violations of Tennessee insurance law which may be revealed in the examination report, it being the intent of this Order merely to adopt the examination report filed by the examiner-in-charge.


