Department of Commerce and Insurance

There will be a hearing before the Commissioner of Commerce and Insurance to consider the promulgation of rules pursuant to Chapter 375 of the Public Acts of 2005. The hearing will be conducted in the manner prescribed by the Uniform Administrative Procedures Act, Tenn. Code Ann. § 4-5-204, and will take place in Conference Room A of the Davy Crockett Tower, located at 500 James Robertson Parkway in Nashville, Tennessee at 10:00 a.m. (Central Time) on Tuesday, October 18, 2005.

- (a) If the Department of Commerce and Insurance or any board, commission or agency attached thereto offers the issuance or renewal of a license, registration or permit via the Internet, an applicant for licensure or renewal may pay the fee for issuance or renewal of such license, registration or permit via the Internet.
- (b) In order to defray the additional costs associated with processing an application for the issuance or renewal of a license, registration or permit via the Internet, the applicant shall pay, in addition to the applicable licensure, registration, permit or renewal fee, a convenience fee in an amount not to exceed \$3.50 plus an amount not to exceed two percent (2%) of the cost of the applicable license, registration, permit or renewal fee.

Authority: Chapter 375 of the Public Acts of 2005.


