Murfreesboro Police Department – Lamb, Jacob A. – Mr. Lamb resigned in lieu of termination. After responding to a call for service, it is alleged that Mr. Lamb lied on a police report and made unprofessional comments towards the victim.

Metro Nashville Police Department – Masteller, Jacob L. - Mr. Masteller was terminated on 04-21-2021 for violation of departmental policies. Mr. Masteller violated the following policies: Personal behavior, Conducting Investigations, Official obligations, False or inaccurate reports and Honesty & truthfulness.

Goodlettsville Police Department – Swift, Brittany N. – Ms. Swift was found to be unfit for duty by a psychologist on 11-10-2020. The confirmation of psychological evaluation was forwarded to POST along with the request for decertification.
