Others present were: Beverly Waller, Executive Director, Terrance Bond, Staff Attorney and Debbie Gean, Administrative Assistant.

JaSanto Williams, Vice-President asked all to join in prayer.

JaSanto Williams, Vice- President asked all to stand for the pledge of allegiance.

JaSanto Williams, Vice-President asked for a roll call.

## **MINUTES**

MOTION was made by Mr. Joe Jones and seconded by Mr. Vernon Winfrey to approve the minutes from the February 23, 2009. Motion carried unanimously.

## **ADMINISTRATIVE REPORT**

Application for a new school – Genesis Career College of Lebanon was inspected and was found to be in compliance with requirements for a Barber School in Tennessee. Ms. Beverly Waller, Executive Director is requesting approval from the board for the opening of the school.

MOTION was made by Mr. Joe Jones and seconded by Mr. Vernon Winfrey to approve the school to be opened. Motion carried unanimously.

Application for a change of location – Antioch Barber Style Academy was submitted for approval.

MOTION was made by Mr. Joe Jones and seconded by Mr. Vernon Winfrey to send an inspector to the school. Motion carried unanimously.

David Louis Hines is requesting approval to take his master barber examination. Mr. Hines was convicted of a felony and has sent a letter since the conviction he has been on good behavior.

MOTION was made by Mr. Vernon Winfrey and seconded by Mr. Joe Joes to allow Mr. Hines to take his master barber examinations with the signed agreement order from the attorney. Motion carried unanimously.

An application from Fashion Lea Carlton was submitted for approval to take her master barber examination. Ms. Carlton's application information on her high school is in question. The application states she attended Family Christian Academy thru the 12<sup>th</sup> grade.

MOTION was made by Mr. Vernon Winfrey and seconded by Mr. Joe Jones to request Ms. Carlton send proof of her 10<sup>th</sup> grade education or GED or a transcript of the courses that were taken at the school she attended. Motion carried unanimously.

Kavan O'Hara is requesting an extension from the 2009 instructor seminar. Mr. O'Hara is requesting the board allow him to attend the CEA (Cosmetology Educators Association) Annual Convention in Las Vegas, Nevada. This convention is for cosmetologists.

MOTION was made by Mr. Joe Jones and seconded by Mr. Vernon Winfrey to deny the request to attend the convention and request he attend the 2009 Barber Instructor Seminar in Tennessee. Motion carried unanimously.

Paige Chatman is requesting an extension from the 2009 Instructor Seminar due to a mental breakdown. Ms. Chatman states she is now living in Pennsylvania and would like to attend the 2010 and 2011 instructor seminars.

MOTION was made by Mr. Joe Jones and seconded by Mr. Vernon Winfrey to require Ms. Chatman to attend the 2010 and 2011 instructor seminars. Motion carried unanimously.

Ms. Beverly Waller, Executive Director informed the board that the University of Memphis Instructor Seminar is scheduled for June 15<sup>th</sup> & 16<sup>th</sup>. Ms. Waller is requesting the board's approval.

MOTION was made by Mr. Joe Jones and seconded by Mr. Vernon Winfrey to approve the University of Memphis instructor seminar. Motion carried unanimously.

### **STAFF ATTORNEY REPORT**

#### **1. 200900432-1**

February 10, 2009 Notice of Violation reports that the inspector observed that a licensed shop owner relocated his shop without giving prior notice to the Board and obtaining a pre-licensure inspection. The owner indicated at inspection time that he had been operating the shop at its new location for approximately two weeks and that he was unaware that he needed to file an application since the shop's license was not expired. As of today's date, a shop relocation application is pending.

*No prior history indicated.*

**Recommendation: Close with a letter of warning re: requirements for relocation of a barber shop.**

#### **2. 200900555-1**

March 13, 2009 Notice of Violation reports that the inspector observed a licensed master barber providing haircut service to a client in a licensed shop while the master barber's license was expired and had been expired since September 30, 2008. The master barber's license is now current.

*Prior History*

*No previous Notices of Violation issued; two warnings issued in 2002 and 2006 regarding sanitation (02) and display of an expired shop license (06).*

**Recommendation: Authorize formal hearing with authority to settle by Consent Order agreeing to payment of a \$250.00 civil penalty.**

#### **3. 200900433-1**

February 5, 2009 Notice of Violation reports that the inspector observed a licensed master barber practicing barbering in an unlicensed shop while her master barber license was expired and had been expired since June 30, 2008. The master barber license remains delinquent as of this date and no shop application is on file as of this date.

*No prior history available*

**Recommendation: Authorize formal hearing with authority to settle by Consent Order and \$1,000.00 civil penalty.**

**4. 200900431-1**

Notice of Violation provides insufficient information to determine whether a violation of the barber law actually occurred.

*No prior history indicated.*

**Recommendation: Dismiss.**

MOTION was made by Mr. Joe Jones and seconded by Mr. Vernon Winfrey to accept the recommendations. Motion carried unanimously.
