#### **MINUTES**

The State Board of Cosmetology and Barber Examiners held a meeting June 17, 2024, at 9:00 a.m. in person in the Training Room of the 11<sup>th</sup> floor, and via Teams.

#### **MINUTES-**

Minutes for the April 2024 board meetings were submitted for changes and/or approval.

Motion made by David McElreath and seconded by Monica Lemons to approve the April 2024 minutes. The motion carried unanimously.

#### PRESENTED BEFORE THE BOARD-

### Kingsport Academy of Hair Design - Change of Ownership

Ms. Angela Braan participated to answer questions for the board. The school is located in Kingsport. This school has been licensed barber school since 2000. The application, enrollment agreement, catalog and contingency plan were all received timely.

MOTION made by David McElreath and seconded by Jeffrey Moran to approve the new school pending changes as outlined and an inspection by a field inspector. The motion carried unanimously.

#### Aspire Barber and Beauty Academy – New Cosmetology School

Mr. Mike Franklin participated to answer questions for the board. Aspire is licensed as a barber school since March 2023. The school is located in Cookeville. The application, floor plan, enrollment agreement, catalog and contingency plan were all received timely.

MOTION made by David McElreath and seconded by Jeffrey Moran to approve the new school pending an inspection by a field inspector. The motion carried unanimously.
