How do I register?

You must first apply to the [Tennessee board](#) for approval to sit for the exam. Visit [the board's website](#) for the appropriate forms, instructions, and fee information. After the board has notified you of your approval, register online with NCEES to reserve your seat for the exam. You will not be required to pay additional exam fees when registering through the NCEES website.

Exam authorization

NCEES will e-mail you 2-3 weeks before the exam with a link to download and print your exam authorization notice. Read it carefully. You will be required to present this document along with a valid, government-issued photo ID upon arrival at the exam site.

Results

NCEES will email you your results of the FS and PS portions 8-10 weeks after the exam date. The board will notify you of your TS exam results by email at the same time.

Exam Dates:

- 1) October 28-29, 2011 – Deadline to have applications (new AND retakes) in to the board office: **July 15**. ABSOLUTELY NO EXCEPTIONS WILL BE MADE.
- 2) April 13-14, 2012 - Deadline to have applications (new AND retakes) in to the board office: **January 15**. ABSOLUTELY NO EXCEPTIONS WILL BE MADE.

EXPIRED (12/31/2009) LICENSEES per TCA § 62-18-114(c)

Per TCA 62-18-114(c) "Certificates of registration shall be subject to late renewal for a period of one year following their expiration date by payment of the renewal fee, plus a penalty in an amount set by the board, for each month or fraction of a month than elapses before payment is received. An person whose registration has expired for more than one year shall make application for registration; provided, that the board may, in its discretion, waive further examination of such an applicant.
