EDUCATION UPDATES

What is one of the most important compliance requirements for your license as a real estate professional in Tennessee? It is your continuing education requirement. The sixteen (16) hours of required education includes ten (10) hours of elective courses, and six (6) hours of the current TREC CORE course. This requirement does not apply to newly licensed real estate brokers, who are required to complete one hundred twenty (120) hours of continuing education within three (3) years from the original date of their broker license issuance.

TREC recently approved new courses that will enlarge your horizons both professionally and personally. To fully engage our licensees in the possibilities of enlarging their horizons, TREC has a tool to review Provider/Courses listings, located at www.tn.gov/commerce/ regboards/trec/education/courses. There, you can search for an area of expertise, current knowledge, and interests. Courses include, buying and selling transactions, ethics, and professional acumen in new areas like AI, ChatGPT, and personal safety courses. As a TREC licensee, review the listings of courses and determine where your interests lie, to help provide a better understanding for your colleagues and clients.

CORE UPDATES

When logging into core.tn.gov you will have to create a new account. Please be sure to use the same email address used to establish your original account. If that email address is used, it will link to the appropriate CORE license.

TREC's licensing system, CORE, has a feature called "authorized representative." This feature allows licensees to designate an authorized representative to manage their CORE licensing account in a way that meets their needs. An authorized representative is granted all access to submit any transaction available for your license. An authorized representative should be an office manager or principal/managing broker. An authorized representative should be familiar with all license and renewal requirements, including but not limited to, continuing education and errors and omissions insurance.

NEW COMMISSION MEMBERS (CONT'D)

Here is more information on the make-up and requirements of the Commission:

62-13-201. Creation -- Members.

- (a) There is created the Tennessee real estate commission, referred to in this part as the "commission," which consists of nine (9) members appointed by the governor, each of whom shall be a resident of this state and shall possess good moral character.
- (b) Seven (7) of the members shall each have been principally engaged as a licensed broker or affiliate broker in this state for at least five (5) years prior to the date of the member's appointment and shall be of recognized business standing.
- (c) Each of the remaining two (2) members of the commission shall be a person who is not engaged in or conducting the business or acting in the capacity of a real estate broker or affiliate broker, nor shall the two (2) remaining members be engaged in the business of real estate financing or development.
- (d) (1) Every member of the commission shall be appointed for a term of five (5) years and shall serve until a successor is appointed and qualifies by subscribing to the constitutional oath of office, which shall be filed with the secretary of state.
- (2) Any vacancy occurring on the commission shall be filled by the governor for the unexpired term.
- (3) No members shall be appointed to succeed themselves for more than one (1) full term.
- (4) The governor may remove any member of the commission for misconduct, incompetency or willful neglect of duty.
- (5) Three (3) members shall be appointed from the eastern grand division, three (3) members shall be appointed from the middle grand division and three (3) members shall be appointed from the western grand division. No more than one (1) of the members appointed pursuant to subsection (c) shall reside in the same grand division. No more than three (3) of the members appointed pursuant to subsection (b) shall reside in the same grand division.
- (6) In making appointments to the commission, the governor shall strive to ensure that at least one (1) person serving on the commission is sixty (60) years of age or older and that at least one (1) person serving on the commission is a member of a racial minority.
