




Human Resources & Staff Development

TDOC Central Office Human Resources provides technical assistance and advice and ensures compliance with Civil Service Rules, EEOC, state law, and policies. Human Resources also implements and monitors personnel-related programs such as employee relations, recruitment and retention, training, performance evaluations, employee transactions, and employee benefits, including accommodations under the Americans with Disabilities Act. The Human Resources division further leads the Tennessee Correction Academy, which offers pre- and in-service training, specialty skills training, and professional development for TDOC's approximately 5,500 employees.

Staff Demographics

TDOC's policy is to provide equal employment opportunities to all applicants for state employment and to provide training, compensation, promotion and all other aspects of employment to current employees without regard for race, color, religion/creed, national origin, sex, age, veteran's status, disability, or pregnancy (except when any of these factors is an existing bona fide occupational qualification).

Divisional Staff

TDOC has five staff divisions: central office, facilities, field staff (Community Supervision and Health & Rehabilitative Services—counted separately in the Division table at right), Tennessee Correction Academy, and the Office of Investigations and Conduct. Central office staff provide overall departmental management and agency-wide administrative tasks. Facilities staff perform

all staff functions in TDOC-managed facilities and include both security and non-security full-time personnel. CoreCivic-managed facility staff are not TDOC employees other than two TDOC liaisons at each location. Community supervision staff include full-time institutional probation/parole specialists, risk/needs assessment counselors, and criminal records units. Some of these positions are located in central office, but they are counted in community supervision staff. The Office of Investigation and Conduct runs both criminal and internal affairs investigations, and the Tennessee Correction Academy is TDOC's primary training and staff development center.

Human Resources & Staff Development

Facilities

TDOC manages ten prisons across the state, and CoreCivic manages four under contract to the department. Both the CoreCivic facilities and the Mark Luttrell Transition Center operated by TDOC are rated through medium security. The rest of TDOC's facilities are rated through close security or maximum security. The table below shows staff at all facilities, though only eight staff members listed in the CoreCivic facilities (two at each) are TDOC employees. The rest work directly for CoreCivic. TDOC employees include 3,825 of all 5,334 facilities staff, or about 72%, and 2,799 of 3,785 facilities security staff, or about 74%.

Vacancy and Turnover Rates

Though facilities, technology and resources can be key to successful services, working in corrections is fundamentally about people having face-to-face interactions with offenders. Attracting and retaining qualified corrections staff has historically been a difficult task, particularly in institutions. TDOC has maintained a goal for several years of reducing turnover and vacancy rates among facility and field staff, especially among Correctional Officers where rates have traditionally been highest. During FY 2025, TDOC instituted pay increases and restructured salary schedules for Correctional Officers and saw improvements in hiring and retention.



Community Supervision

Community supervision occupies a space between incarceration and full freedom. It can serve as a substitute for incarceration for offenders without significant criminal history or to help inmates successfully transition back into their communities. At the end of FY 2025, TDOC's staff supervised almost 60,000 probationers and nearly 12,000 parolees. Community supervision staff include full-time institutional probation/parole officers, risk/needs assessment counselors and criminal records units. At the end of FY 2025, TDOC had 796 Probation/Parole Officers and 318 additional Community Supervision staff.

Vacancy and Turnover Rates

Maintaining workable caseloads for field staff can be an important part of successful inmate transitions, allowing support many supervisees need. TDOC has maintained a goal of reducing Probation/Parole Officer vacancies and turnover rates to ensure probationers and parolees have that support.

Surrounding State Salary Survey

Tennessee is not alone in struggling to keep correctional officer positions filled. Each year, the Tennessee Department of Human Resources surveys neighboring states to determine if TDOC's most difficult to fill correctional positions offer comparable salaries. Results of that survey for FY 2024-25 show some salary increases in surrounding states, but only Arkansas shows one of comparable size, and it is for only a small number of officers and only brought them to the middle of salary ranges. Two surveyed states (Mississippi and North Carolina) showed average pay declines in 2025 compared to 2024.

Tennessee's new recruits are making an average of 10 percent more than similar positions in surrounding states, with only Alabama paying more. After step increases, Tennessee's more experienced officers are making an average of 20 percent more than similar positions in surrounding states, and, again, only Alabama is paying that position more. Correctional Officer careers can be rewarding, though they can also be stressful and occasionally even dangerous. Innovative salary changes were needed to address these realities, and early results are promising

Changes to Tennessee correctional series structure and range contributed to the lowest vacancy rate in these positions in more than five years. Training classes for new Correctional Officer 1 hires are also the largest they have been since then. Probation and parole officer series positions also have their lowest vacancy rates since prior to the pandemic. These positions also saw a pay increase, though not the same kind of pay structure change. Keeping probation and parole officer positions filled, while sometimes challenging, has never been as difficult as keeping correctional officer positions filled.

Population: Type of Facility

Population Type and Location

TDOC tracks basic information of persons convicted of state felonies and sentenced to serve either in TDOC facilities or in county facilities. State felons may serve in one of ten facilities operated by TDOC, one of four facilities operated by CoreCivic, or one of over 100 county-operated jails or workhouses.

Backup vs. Local

Many felon offenders in county jails have short sentences and are assigned to serve their full terms in jail. These are classified as “Local,” while those awaiting transfer to a TDOC facility are classified as “Backup.” County jails have significant churn in their populations, making it sometimes difficult to get an accurate count of Local vs. Backup. An example of a case confounding an accurate count would be a parolee who earlier served in a TDOC institution and is now brought in for a violation. They are still officially designated as TDOC, though their incarceration time for a parole violation is likely short and will be served in jail. The best count we can produce classifies anyone sentenced to TDOC but physically in a jail as Backup, with the rest of the felon jail population counted as Local. This almost certainly overcounts Backup.

Sentences of one year or less are assigned fully to county jails (Local). Some counties have agreements with TDOC to extend that to two years. Tennessee’s largest counties keep inmates serving up to six-year terms as Local. Other than awaiting transfer to a TDOC facility, Backup populations may include inmates

- Sentenced to “split confinement” (some local sentence time in a county jail paired with time under community supervision conducted by TDOC),
- Initially sentenced to TDOC, serving a short time for violation of community supervision terms,
- Temporarily housed in county facilities to attend court appearances,
- Close to release to community supervision and transferred to a jail in their assigned supervision county to prepare for transition, and
- Requested by local officials to remain in their counties.

TDOC does not take custody of individuals until they have been convicted of and sentenced for a state felony. TDOC does not take custody of those convicted of federal crimes or of misdemeanors.

FY 2025 Totals

Counts in this section include all 40,906 inmates who served some time for a felony conviction in a TDOC facility or county jail during FY 2025, so they exceed the number that were in facilities at any given time. Among these, 1,855 individuals in jails and 73 in TDOC institutions lacked updated sentencing information at the end of the fiscal year and will appear in many tables under “Unknown.” There may be a lag between conviction dates and the date information from a Judgement Order is entered into the system. During that lag, these individuals have been sentenced and are present in a TDOC facility or jail, so they are included in population data, but the specifics of their conviction and sentence are not known. Locations are as of June 30, 2025, or the inmate’s release date if that was earlier.


Population: Demographics

Population Demographics

Age

Tennessee does occasionally try, convict and imprison juveniles as adults, though the numbers are quite small. During FY 2025, 16 juveniles were incarcerated for at least some time while they were below the age of 18, though only nine were still below age 18 at the end of the fiscal year. Of those, four served time only in county jails. Among all inmates, the most common age group was 30 to 39 years. Fewer than one in 10 inmates were over 60.

TDOC generally reports county of conviction rather than residence. Convictions in counties in each of Tennessee's three Grand Divisions roughly match their population breakdown.



Population: Demographics

Race


Race is self-reported by TDOC inmates. They may choose only one race from: White, Black, Hispanic, Asian and Native American (characterized by “I” for “Indian” in TDOC’s data and in inmate choices). If they do not choose one, race is listed as “Unknown.” There is no separate ethnicity designation. Unknown, Asian and Native American combined to just under one half of one percent of the FY 2025 population. Just 2.6 percent of inmates described their race as Hispanic. The remaining inmates chose either White (60.4%) or Black (36.5%). Census estimates for Tennessee in 2023 suggest black inmates are overrepresented relative to the state’s adult population as a whole, while white inmates and those from other racial groups are underrepresented.



Gender

Men are incarcerated at far higher rates than women nationally and in all states, including Tennessee. In FY 2025, 87 percent of inmates were male, and 13 percent were female. In any given single-day snapshot, however, women make up anywhere from just under to slightly over 10 percent of Tennessee’s state felon inmate population. This difference between daily snapshots and a count of all inmates moving through the system in the fiscal year suggests women are more likely to stay for a shorter time. Bureau of Justice Statistics (BJS) tracks population demographic data for state prisons, though their gender counts look only

Tennessee has a higher percentage of female inmates than the average for all states



at those with a sentence of at least a year. In that data, Tennessee ranked 11th highest for female percent of incarcerated population among the 50 states. The state with the highest percentage of women as a part of their incarcerated population was Idaho at 15.5 percent, while Rhode Island was lowest at 2.9 percent. The rate for all states was 7.1 percent.

Population by Institution

Multiple measures are included in the table below for both TDOC- and CoreCivic-managed facilities.

Fiscal Year Total

This count includes offenders either assigned to the institution on June 30, 2025, or on the last day they were incarcerated if they were released prior to June 30, 2025.

Average Monthly Actual

Actual counts are the numbers of offenders physically present in the facility. Offenders assigned to a facility might not be physically present for a variety of reasons, the most common of which are court appearances and hospital stays. Others include offenders temporarily out on bond, work release, or furlough.

Average Monthly Assigned

This count includes offenders assigned to the institution for the foreseeable future whether they are physically present or not.

Average Monthly Capacity

Operating capacity is based on the average number of beds available to house offenders while maintaining safe operations. The number of offenders assigned is compared to capacity because offenders' physical absences from assigned facilities can be unpredictable and certainly cannot be relied upon as a method for staying within operating capacity. Facilities must consistently have enough beds available to accommodate their full assigned populations while maintaining safe operations.


TDOC Population Over/Under 50

TDOC Population by Selected Demographics Five Year Comparison


Over/Under 50 Years of Age




TDOC Population by Gender






TDOC Institution Population


TDOC Institution Population 25-Year Comparison

Community Supervision Population

Community supervision is a way for individuals convicted of crimes to serve their sentence outside of prison, while still being monitored and supported by the justice system. It aims to rehabilitate offenders, reduce recidivism, and ensure public safety. This approach is often used as an alternative to incarceration or as a transition from incarceration back to the community. Individuals on community supervision are supervised by probation or parole officers who monitor compliance with specific court-required conditions and provide support services. While providing support, community supervision also ensures public safety by monitoring offenders and taking action if they violate their terms of supervision.

Probation and Community Correction

Probation is the release by a court of a person found guilty of a crime without imprisonment, subject to conditions imposed by the court and to the supervision of the Department of Correction. Probationers may be placed on probation as part of a split confinement, where they spend some time in jail before release to probation, or they may be sentenced directly to probation. All probationers are required to follow the terms and conditions listed on their probation order, which may include special conditions. Likewise, Community Corrections allows sentencing of non-violent felony offenders to community-based alternatives to incarceration to reserve confinement for violent offenders.

Parole

Parole is the release of an offender to community supervision by the Board of Parole (BOP) prior to the expiration of their sentence. Release is subject to conditions imposed by the BOP. Parolees may also be given post-parole special conditions such as release to a halfway house or periodic substance use assessments. They must follow those conditions as part of parole supervision. Offenders granted parole are not released from prison until a release plan has been approved that both identifies where the parolee will live and work and details their support systems.

Security Incidents at TDOC Institutions

Like any Department of Correction, TDOC faces ongoing challenges with security incidents. Though sometimes violent, the most frequent security incidents by far involve either low-level non-cooperation or contraband: primarily drugs, drug paraphernalia, cell phones and weapons. While less common, assaults do occur, both against other inmates and against staff. Violence of any kind within facilities is a significant concern, but violence against staff is especially alarming.

Security incidents do not have to involve inmate violations or significant bad behavior. Inmate illness requiring hospitalization is a common incident, as is a minor disturbance. Each incident type has a “class” to identify its severity, with “A” most severe, “B” a bit less severe, and “C” least severe. Systemwide, 39.3 percent of TDOC’s incidents were Class C, while Class A, the most severe, made up a similar 39.4 percent of incidents. Class B incidents were least common at 21.3 percent.

The top 10 most common incident types made up 78 percent of all incidents reported in FY 2025. These 10 included four “Class A” types, two “Class B” types, and four “Class C.” The most common incident overall was possession of a “non-commercial knife.” These are largely homemade, with an offender sharpening a found item and fashioning it into a weapon of sorts. This incident changed from a “B” level to an “A” level in recent years and is the main reason A-level incidents make up a higher percentage overall than they did in years prior.

The number and severity of incidents are different for different institutions. One might expect a maximum security facility like Riverbend Maximum Security Institution (RMSI) to have larger numbers of severe incidents, and, relative to their population, they do. With very different population sizes across institutions, it is more useful to consider incident rates than absolute numbers when comparing them. The table below shows rates per 1,000 offenders (average population over the fiscal year) for each TDOC institution. Rates are included for incidents overall and for each class of incidents by level of severity. Other maximum security institutions include DJRC, DSNF, MCCX, and WTSP. Close security institutions include BCCX, NECX, NWCX, and TCIX. The four CoreCivic institutions (HCCF, SCCF, TTCC, and WCFA) and the Mark Luttrell Transition Center (MLTC) are medium security.

Security: Inmate Deaths by Institution

Inmate Deaths

If an offender dies while at a TDOC institution, a rigorous procedure is triggered in which a multitude of individuals are notified, each with a part to play in investigation, evidence preservation, mitigation of any continued risk to inmates or staff, and notification of family members. County Medical Examiners, coroners, or the state Medical Examiner must examine the body and make a pronouncement. If they cannot, a licensed physician must be contacted to do so promptly. Deaths in TDOC institutions are thoroughly investigated, recorded, and reported to the Tennessee Bureau of Investigation in compliance with Tenn. Code Ann. § 38-10-102.

During FY 2025, 159 offenders died while in TDOC custody. For 40 of those deaths, TDOC has not received a death certificate, and the cause is still pending. All deaths occurred either in a TDOC facility (85) or in a hospital (74). Among the deaths pending the receipt of a death certificate to confirm cause, 18 occurred in a facility and 22 occurred in a hospital. More deaths occurred at the DeBerry Special Needs facility than at any other because it has the most advanced medical infrastructure and it is where the most severely medically needy inmates are sent. In a few cases, an inmate was sent to DSNF as a temporary medical transfer rather than a permanent move, and those inmates' home institutions are still considered to be the ones they were permanently assigned to at the time of their death. No deaths occurred at MLTC during FY 2025.



Inmate Custody Assessment Form (CAF) Classifications - June 30 each fiscal year


At intake and periodically thereafter as needed, each inmate's risk of violence and/or escape is assessed. Risk measures are based on past violence, severity of current and past offenses, any history of escape attempts, and any past disciplinary reports. Classifications are determined by review of a panel with a chair and members representing security and treatment. Classifications include Maximum, Close, Medium, and Minimum. For some inmates recently arrived or in transition, classifications may temporarily be unavailable and result in a value of "NA." CAF assessment data primarily determines institutional placement and includes only TDOC in-house inmates. Backup and Local inmates are not included in the data.



Security: Custody Classification Level

Inmate Custody Classification Level – June 30 each fiscal year

Custody classification is similar to CAF classification, considering many of the same factors. Rather than determining institutional placement, custody classification informs placement and activities within the institution. Classifications are similar, though a CAF “Close” may become a custody “Medium” once an inmate is in an institution certified to handle CAF Close designations. In addition, Minimum classifications are broken into three levels to inform allowed activities: Minimum Restricted, Minimum Direct, and Minimum Trusty. Generally, only inmates classified Minimum Trusty may have off-property service jobs that interact with the public. For some inmates recently arrived or in transition, classifications may temporarily be unavailable and result in a value of “NA.” Data includes only TDOC in-house inmates. Backup and Local inmates are not included.




Recidivism

TDOC Recidivism Rates

The National Institute of Justice defines recidivism as “a relapse into criminal behavior after intervention for a previous crime.” Recidivism rates measure the percent of inmates who reoffend after release. Differences among states and at different levels of government in data quality and in what counts as reoffending make research into the exact nature of these relationships difficult. Nonetheless, most research concludes interaction with the judicial system is a predictor of future interaction with the judicial system, and more serious interactions strengthen that relationship. An arrest is a weak predictor; a conviction is a slightly stronger predictor; incarceration is stronger still. Once a released inmate reoffends, the chance that they will break the cycle of crime and incarceration reduces significantly. Preventing recidivism, especially that first instance, can have noticeable impacts on crime rates.

As pandemic effects fade, the long-term recidivism rate trend remains unclear



Pandemic Effects

As states responded to the pandemic in 2020 and 2021, many released prisoners early to reduce the risk of spread of Covid-19 in institutions. Concerns that these early releases would commit additional crimes not only failed to materialize, but recidivism rates for these release year cohorts reached record lows in several states, including Tennessee. While TDOC did not release large numbers of offenders early like some states (New Jersey released 40 percent of their prison population for example), there was a notable increase in grants of parole during the pandemic years. Multiple theories have been posited for the lower recidivism rates, and the data are just beginning to come in to either validate or refute those theories.

Recidivism

Disruptions in Judicial System Processes

- Courts were backlogged, with fewer trials and delayed hearings. When offenders did have renewed engagement with the system, it took longer for those cases to reach resolution.
- Arrests declined in many cities during 2020, partly from lower police activity and lower reported crime, leaving fewer opportunities for new charges, which could artificially lower recidivism rates.

Remote Supervision and Monitoring

- Probation and parole offices often reduced in-person check-ins, drug testing, and technical violation enforcement during the pandemic.
- Technical violations (missed appointments, positive drug tests) are a big driver of returns to prison, so reduced reoffending may have been a result of reduced requirements and reduced monitoring.

Increased Mortality

- People who have been incarcerated tend to be more medically vulnerable than the general population, with higher rates of chronic diseases, tobacco use, illicit drug use, and mental health diagnoses and less access to high quality health care.
- Medically vulnerable individuals were at greater risk of death from Covid-19 infection. A higher than usual mortality rate in a release class would reduce the number of offenders who could recidivate.

Non-Random Early Releases and Initial Diversions

- Offenders who were released early tended to be non-violent, older, and more medically vulnerable compared to the overall prison population.
- These targeted early releases would have a statistically lower likelihood of recidivism, reducing the risk profile of the release year cohort.
- Prison and jail admissions were significantly decreased in many states—including Tennessee—during 2020 and 2021. If diversions were increased for those who were medically vulnerable and older and perhaps for first-time offenders, this would lead to fewer low-recidivism-risk offenders available for release in subsequent years.
- Both changes could lead to a reciprocal increase in recidivism rates as the system readjusts, since these lower-risk offenders are no longer part of the release cohorts they would have been in, where they would have helped reduce the risk profile. These smaller release cohorts would be more easily affected by the riskier offenders who remained.

All these effects were complicated by confounding factors, such as disruptions to education and reentry services that generally reduce the risk of recidivism. Finding employment after a pandemic-era release was almost certainly more challenging than usual, and it is an important predictor of successful reentry.

Further, states across the country were just beginning to see results from spending increases and a fresh focus on reentry services that came with the federal Second Chance Act. Recidivism had already been on the decline in many states, perhaps due to increased attention in those states to education, rehabilitative services, and easing the challenges of transition back into communities.


Effects on Recidivism Rates in Tennessee

How these many factors affected recidivism rates in Tennessee is hard to say just yet. With the three-year lag in rates (the newest recidivism rates—for 2024—reflect activity of those released in 2021), any post-pandemic picture is only beginning to emerge. Tennessee did enjoy its lowest recidivism rates since they have been measured for the 2019 and 2020 release cohorts, and rates have turned back upward since. Some of these important disruptors may have caused a sharper reduction than would have occurred for release years 2019 and 2020 and a reciprocal sharp, though smaller, correcting increase.

- Tennessee did increase releases to parole during the pandemic, and those releases did favor more medically vulnerable offenders. Parole releases only fell all the way back to pre-pandemic levels with the 2023 release cohort, whose recidivism rate will not be known until 2027.
- Tennessee had a long-term trend of release cohorts growing smaller, but 2019 and 2020 briefly stalled that trend. At the same time, admissions to both prisons and jails decreased markedly in FY 2020 and FY 2021, with those who committed less serious crimes—and were perhaps less likely to recidivate—probably being diverted at higher rates and never being incarcerated or joining a release cohort.
- Tennessee’s prison recidivism rate hit its low with Release Year 2019, suggesting it was more the post-release effects around a slower court system and lighter supervision that fed the drop for prisons.
- Jails reached their lowest rate with Release Year 2020, so their declines may have had more to do with fewer admissions, increased releases, and non-random releases.

Another difference seen through these same years is the portion of release cohorts made up of women. Gender differences in recidivism rates are more noticeable in prisons than jails, but women recidivate at lower rates in both institution types. The portion women make up of jail release cohorts has remained steady at around 20 percent, but the portion they make up of prison releases began increasing in 2018, before any pandemic changes. Running at around 11 percent prior to 2018, women were 13.5 percent of 2018 prison releases, in the 14 percent range in 2019 and 2020, and rose to a high of almost 16 percent in 2021. At the same time—as seen next in gender comparisons—their recidivism rates were increasing. With just around 1,700 women in prison at any time in 2021, 870 were released—about half. Women’s rate of release has always been higher, but half likely included some who drove up the cohort’s recidivism risk.


One way to smooth short-term fluctuations is to look at three-year averages rather than single years. These three-year averages for Release Years 2014 to 2020 show a less dramatic but steady downward trend. This trend flattens in recent years but does not reverse. The disturbance of the pandemic years is still visible, but a line matching the slope of the downward pre-pandemic trend predicts what a return to that trend will look like if it comes in the next few years.





Recidivism Rates by Gender

Though these graphs are designed to show a close view of levels and changes, it is worth note that the range of recidivism rates depicted in them is not that large. In prisons, women’s range is 11.6 percent and men’s is 11.4 percent. In jails, men’s range is just 7.4 percent while women’s range is 10.7 percent. Though women’s rates are lower than men’s, there are times when they get closer. The gap between men and women in prisons in Release Year 2021 is just 6.1 percent, the lowest in a decade. In jails, just before the pandemic, women’s rates were barely below men’s, with less than one percent difference for three years running. Though a larger gap opened with pandemic releases, it seems to be closing again.

Recidivism Rates by Release Type

When offenders leave prisons and jails, they go to various types of release. If their sentence has expired, they are discharged, or they may earn an earlier release into community supervision through parole, probation, or community correction. For the most part, parole follows incarceration while community correction and probation are diversion programs to avoid incarceration. There are cases, like split sentences or brief revocations for technical violations, where probation and community correction do follow incarceration. Everyone in this data was incarcerated for at least a short time. Without incarceration there is no release date and no recidivism cohort.

Probation and Community Correction most likely run higher because they are diversion programs. For someone who was diverted to end up incarcerated, they must already have had some kind of violation. That first violation makes additional ones more likely. As with other subsets—and other than Community Correction—these fell for Release Years 2019 and 2020 then increased again in Release Year 2021.

Education, Jobs, & Rehabilitative Programs

Rehabilitative Programs

General goals of treatment programs include school enrollment and/or employment, cessation of substance abuse, successful social interaction, and ultimately cessation of criminal behavior. Studies consistently show it takes a variety of programs to effectively reduce recidivism, violence, and addiction. Although programs within prisons are primarily aimed at reducing recidivism, they may have other positive effects like reducing misconduct within institutions.

This data includes only those in institutions. It is a snapshot of assignments on June 30, 2025. Some number of inmates in institutions are always ineligible for assignment. The largest portion of these is assigned to punitive segregation or maximum security and cannot mix into the general population. Other reasons an offender may be ineligible include medical or mental health conditions, that they are awaiting transfer, or that they are temporarily out of the facility, such as for a court appearance.

The number of positions assigned is larger than the number of offenders assigned because some offenders have multiple assignments at the same time. This is especially common among offenders who both have a job and are pursuing academic or vocational training, though other combinations also occur.

Offenders who are available and able to be assigned are expected to work and/or engage in treatment or training. A small number is always unassigned for transitional reasons, like they have recently arrived or just finished another program and are awaiting a new assignment. This unassigned portion generally stays around four to five percent of eligible inmates.

TDOC provides Adult Basic Education (ABE), Career and Technical Education (CTE), and Post-Secondary Education (PSE), along with library services at each TDOC facility.

Education, Jobs, & Rehabilitative Programs

Jobs/Work Programs

Offender jobs teach responsibility, work ethic, and marketable skills. Work rules mimic requirements of jobs outside prison, and a system of incentives and disincentives are in place to help promote the concept that job advancement is connected to positive work performance. Many offenders work in support services inside prisons, while some others work as teacher's aides, counselor aides, clerks, and library assistants.

Some inmates work in real-life job settings through TRICOR (Tennessee Rehabilitative Initiative in Correction). The General Assembly created TRICOR in 1994 with the mission to prepare offenders for success after release. The self-supporting state agency provides occupational and life skills training through job training, program opportunities, and transitional services designed to assist offenders with successful reintegration into society. TRICOR operates multiple businesses, including agriculture, business services, call centers, consumables, production services, cleaning products, and uniforms. They offer Tennessee's state, county, and local governments, nonprofit organizations, and education institutions quality goods and services and competitive pricing. TRICOR data presented here is a snapshot of June 30, 2025, job placements. Both the number of positions filled and available can vary.

Community Service

Offenders also provide community service to nonprofit organizations and state, local, and federal government agencies. Both TDOC inmates and those under community supervision do unpaid service work in their communities.

In all TDOC institutions, inmates who are not involved in academic or vocational programs are required to work in support service roles throughout the prison including landscaping, janitorial services, or food services. Institutional Worklines pick up trash along roadways, clean out underbrush in fields surrounding the perimeter of the prison, cut firewood, and plant, tend and harvest crops. Some facilities provide workers to local churches and cemeteries. Two facilities have groups of inmates who train dogs, either to become service animals to citizens with that need or to prepare rescue dogs for successful adoption.

The Community Supervision Service Program also provides workers to programs in their counties. Probation/Parole Officers are responsible for coordinating this program to facilitate appropriate assignments for offenders and monitor them to ensure they report to agencies as agreed. The Work Project Program, required by legislative action in 1984, is a special condition attached to probation certificates requiring offenders on probation to complete a specified number of work project hours in the community at no expense to Tennessee citizens.

Each year, TDOC compiles hours worked in community service and assigns a minimum-wage based value to the work performed over the year.

Clinical and Behavioral Health Services

TDOC's Clinical Services division combines oversight of medical, dental, pharmacy, mental health, and substance use programming for over 20,000 offenders for a model of care that promotes a "whole patient" approach to providing health care services. Upon intake into TDOC's system, all offenders receive extensive medical, mental health, substance use, and dental screening to identify their health status and treatment needs.


Health Services

TDOC strives to improve the health of its inmate population while providing a safe housing and working environment. Health Services offers access to medical and dental sick call, emergency care, chronic care clinics, medication management, diagnostic tests/procedures, infirmaries, inpatient hospitalization, and specialty services. Communicable illnesses remain a major focus, and the department is additionally implementing standardized treatment plans and guidelines for management of chronic illnesses such as diabetes, hypertension, hepatitis c, and asthma. Health Services utilizes managed care practices through contracted medical providers.


Health classifications are determined at intake examination and are updated as needed. Those classified "A" can participate in regular activity without restriction. A classification of "B" suggests a physical or mental condition that places some limitations on an inmate's activities. A "C" classification indicates serious, activity-limiting health issues.

Some offenders of all classifications are at every institution, but over a fourth of the population at DJRC is Class B, and a third of the population at DSNF is as well. DSNF further houses a fourth of offenders with a Class C health status, making up about one offender in seven assigned there. Only MLTC has no offenders with Class C health status, and it has only a few with Class B. A small number of offenders (less than one percent) are awaiting classification and have an "M" signifying a missing value.

Through contracted medical services, TDOC utilizes managed care practices to assure efficient management of medical and dental expenditures and operations. The utilization management system is used to pre-approve all requests for specialty consultations. Clinical Services is committed to providing a level of care within the department's infirmaries allowing TDOC to treat offenders at the institutional level when clinically appropriate, avoiding more costly outpatient care. Also when appropriate, medical telehealth visits can be beneficial to

both inmates and TDOC, offering easier access to a wider range of providers.

Clinical and Behavioral Health Services

Correctional inmates tend to be more medically vulnerable than the general population, and many require ongoing care for chronic illnesses such as HIV, hepatitis c, and cancer, among others.



Clinical and Behavioral Health Services

Inmate Medical Classification Level – June 30 each fiscal year

At intake and periodically thereafter as needed, each inmate receives a full medical examination to determine health needs. Medical classifications can be A, B, or C. Class A indicates there are no clinical restrictions or accommodations needed. Class B indicates there is a physical/mental condition that places certain limitations on the capabilities of the inmate, and Class C indicates the presence of serious limitation(s). For some inmates recently arrived or in transition, classifications may temporarily be unavailable and result in a value of “M” for Missing. An investigation into the perennially high percentage of inmates with an “M” found an issue with the way the data extraction program was pulling health classifications from TOMIS. That issue has been resolved, and missing values are significantly reduced. Data includes only TDOC in-house inmates. Backup and Local inmates are not included.

Behavioral Health Services

TDOC's behavioral health services goals are to reduce the effects of serious mental illness, maximize each offender's ability to participate in programs while maintaining a safe prison environment for offenders and staff, and help prepare offenders with mental illness and/or substance use treatment needs to successfully transition from incarceration back to the community. A continuum of services is provided including psychological assessment, case management, medication management, crisis intervention, individual/group therapy, substance use treatment services, and sex offender treatment.

Inmates requiring Levels of Care IV and V are generally sent to DSNF, though all facilities can institute a suicide watch when needed. Facilities with Supportive Living Units include BCCX, MCCX, NECX, NWCX, and the Women's Therapeutic Residential Center at WTSP. During FY 2025, TDOC housed 11,565 inmates with Levels of Care above Level I.



Substance Abuse Services

TDOC's substance use disorder program aims to break the cycle of substance use, criminal behavior and incarceration to provide a safe and drug-free living and working environment both within state correctional facilities and in local communities. Participants work closely with treatment staff to develop individual treatment goals and strategies and are ultimately responsible for their own recovery. A variety of treatment options are available to offenders based upon their assessed level of treatment needs, including residential and outpatient. Participants are drug-tested at intake and then randomly or for cause throughout treatment.

Positive all-cause (administered for any reason) inmate drug tests results by quarter. Positive includes refusals.

Mental Health Diagnoses


Many inmates have multiple diagnoses. The most common diagnosis is alcohol and/or substance use disorder, though several others appear frequently as well. Among those with a mental health diagnosis, only 34% have just one. About two thirds of inmates with diagnosed disorders have comorbidities, creating a complex set of mental health challenges.

Among those with an alcohol and/or substance use disorder and co-existing conditions, the most common co-occurring disorders are:

- Post-traumatic stress disorder: 21%
- Major depressive disorder: 18%
- Adjustment disorder: 16%
- Anxiety disorder: 14%

Others often co-occur as well. Bipolar Disorder and Anxiety Disorder are the most likely to be part of a complex set of more than two mental health diagnoses.

Mental Health Diagnoses by Major DSM Group

Up to three diagnoses can be counted for each individual, leading to more diagnoses than inmates. In FY 2025, Behavioral Health reported 23,328 total diagnoses reflecting 12,096 inmates with at least one diagnosis and 7,904 who had no mental health diagnoses. Multiple mental health challenges make access to services even more important for successful reentry.


The number of TDOC inmates diagnosed at any time with a severe, persistent mental illness (SPMI) requiring ongoing mental health care varies monthly but tends to fall close to 10,000, or about half the population.


At intake and periodically thereafter as needed, each inmate receives a full mental and behavioral health examination to determine treatment needs. Those meeting criteria for a Diagnostic and Statistical Manual of Mental Disorders (DSM) diagnosis will receive appropriate services. The DSM-V is a comprehensive guide used by healthcare professionals to diagnose mental disorders. It provides standardized criteria for identifying and classifying various mental health conditions, ensuring consistency and reliability in diagnoses. Each disorder has specific criteria that must be met for diagnosis, including symptom duration, severity, and impact on daily functioning. The inmate population in these charts is TDOC only and does not include Backup or Local.

Inmates with Diagnostic and Statistical Manual of Mental Disorders (DSM) Diagnoses by Major Category - June 30 each fiscal year


DSM-V diagnoses are broken into broad categories including Alcohol and Substance Use Disorder, Severe Persistent Mental Illness, and all other DSM-V diagnoses. In years past, only the primary diagnosis was reported, but this led to inconsistent reporting on the prevalence of some disorders. After a large substitution in primary diagnosis from Alcohol and Substance Use Disorder to Severe Persistent Mental Illness in FY 2023 upended annual trends, the decision was made to include up to three diagnoses, the maximum recorded in TOMIS. The percents shown represent the percent of inmates with that diagnosis. Since many inmates have multiple diagnoses, these percents do not sum to 100. FY 2024 was the first year including multiple diagnoses, which can be seen in the sharp increase in total diagnoses that year.



Clinical and Behavioral Health Services

Inmates Classified as Sex Offenders - June 30 each fiscal year

Tennessee requires registration as a sex offender for conviction on or after November 1, 1989, of a criminal offense as defined in TCA 40-39-202(20); conviction prior to November 1, 1989, of a criminal offense as defined in TCA 40-39-202(20)(B); conviction for a sexual offense with a victim who was under the age of 13; an adjudication of delinquency for any act committed on or after July 1, 2011, as defined in TCA 40-39-202(29)(A); and any conviction as a violent sex offender as defined in TCA 40-39-202(30). Though the statute defining offenses is updated every July (generally to include more offenses), the number and percent of inmates classified as sex offenders each year is remarkably consistent. This inmate population is TDOC only and does not include Backup or Local.







Work Assignments, Single Day Snapshot: June 30, 2025








Top 5 STGs by Confirmed Members




