- Board agreed suspension was necessary; however, termination extreme.
- Recommend time served, re-training, and reinstate as volunteer.
- JR Davis called vote: unanimous for all in-person and zoom, 9 votes
- Genevieve Turner will write letter.

Maurice Guinn

- Terminated from MCCX and all TN facilities March of 2024 for being on approved call list of an incarcerated individual. Volunteer since 2019. Board member of Focus Ministries.
- States he was unaware of TDOC policy for no contact.
- We must be conscious of what we are doing. Police ourselves and make sure we are complying.
- It is very clear in training, no communication. He has had many trainings/re-trainings.
- No proof of inappropriate conversation; however, it is policy no contact.
- He is not a registered mentor, but a volunteer.
- Excuse of not knowing policy, is not acceptable. This is specifically in training.
- Recommend time served, re-training, and reinstate as volunteer.
- JR Davis called vote: unanimous for all in-person and zoom, 9 votes
- Genevieve Turner will write letter.
