# INITIATIVE SUGGESTION - RAEANNE HANCE AWEC RESOLUTION

### AWEC RESOLUTION UTILIZATION ON THE USE OF PERSON-CENTERED LANGUAGE IN THE CRIMINAL JUSTICE SYSTEM

Whereas person-first language refers to language that focuses first on the individual as a whole person, rather than their situation, condition, or diagnosis, and

Whereas people-first language avoids turning one aspect of a person's life into an all-encompassing label, and decreases the conscious or unconscious marginalization and dehumanization of people and groups of people, and

Whereas reliance and use of non-person-centered labels for people involved in the legal system can produce and reinforce certain stereotypes and stigmas, and

Whereas stigmas have been shown to result in exclusion from significant social and economic resources and services that may affect their health and well-being (Winnick & Bodkin, 2008), and

Whereas stigma creates negative attitudes which can limit engagement by persons released from custody supervision with their community, reducing their interest as well as the community interest and support in the ability and willingness to work, access treatment and services, participate in civic affairs, engage in positive, pro-social activities and relationships, and re-connect, repair, and improve family relationships, and

Whereas words such as "con", "criminal", "defendant", and "arrestee" restrict people to groups that do not acknowledge their human identity and reinforce existing stereotypes they based solely on the interactions of the legal system, and

WHEREAS the Association of Women Executives in Corrections specifically states the guiding principles of HUMANITY, JUSTICE, PROTECTION, OPPORTUNITY, DIGNITY, KNOWLEDGE, COMPETENCE and ACCOUNTABILITY are consistent with sound correctional policy; evidence-based research and a culture which contributes to the potential for successful reentry to the community and should be equally available to all individuals in custody, those released to the community and others placed on community supervision with opportunities for better outcomes.

THEREFORE, correction agencies should develop policy based on the logic of "people-first" language and purge the criminal justice vocabulary of language that turns an individual record into an indelible brand.

THEREFORE, agencies should develop policy that purge and discontinue terms such as "inmate," "exoffender," "prisoner" and "ex-convict" in an effort to eliminate the oftentimes dehumanizing language of the criminal justice system, that is, defining people by the crime they were convicted of or their 'status' in the criminal justice system.

THEREFORE, BE IT RESOLVED that the Association of Women Executives in Corrections supports vigorous exploration of all aspects of corrections operations to include an examination and inclusion of person-centered language in correctional policies and procedures.

THEREFORE, BE IT FURTHER RESOLVED that the Association of Women Executives in Corrections supports the development of the preferred terminology referring to persons in the correctional system is incarcerated individual, not inmate, and in the probation and parole system is: individual on probation, not probationer, individual on parole, not parolee, individual on community supervision and client.

# INITIATIVE SUGGESTION - TOM HALLQUIST REGIONAL CONFERENCES

#### Faith in Corrections Regional Conferences

This is a proposal to the Tennessee Department of Corrections (TDOC) and the Tennessee Community Resource Board (TCRB) to initiate regional Faith in Corrections Conferences for 2024, as discussed at the TCRB meeting in December of 2023. Due to the success of the October Faith in Correction Conference panel discussions, conversations were established to initiate conference agenda and topics. I met with Chris Southerland and Ron Miller here in Nashville and we discussed formats for the Florida Faith in Correction Conferences. We discussed a format whereas the conferences would incorporate mindset changes for the inmates, families, volunteers, and DOC staff. The initial discussion would be a conference that included inmates, family members, volunteers, and Doc officials. LoveWorks, formally Timothy's Gift would supply the music and a motivational message.

The Purpose of the family participation would be to show that there is progress being made by having courses offered in Parenting from Prison, entrepreneurship, Anger management, etc... The volunteers and DOC officials would determine topics for discussion. I am meeting with Chris and Ron and Florida officials in March to further initiate these discussions. I have been scheduled to present at this time with FDOC officials the curriculum of Mindset Change for DOC officials.

#### Benefits

- Allow units to participate in positive activities that would be an example for other units if they wanted to participate in similar positive programs.
- The participating unit would be selected by low behavior incidences. Thus, causing less administrative concerns for the DOC staff.
- Allow DOC officials to present a message of hope to the inmates and families if mindsets are changed to a
  positive instead of negative.
- 4) Allow families to participate and see what programs are being taught and the benefits.
- Allow the inmates to develop self-esteem for their accomplishments by being recognized by volunteers and DOC staff.

#### Consequences

- Any contraband brought in by family members or other inmates would result in severe consequences for the family and inmates involved which would result in loss of privileges.
- 2) Any behavior problems could result in loss of privileges for inmates and or family members.

In February, I asked David Dodson his opinion and the possibility of having family and inmate participation in the TCRB Faith in Correction Conferences and David suggested we make a formal request to the TDOC for their approval and participation. I truly appreciate David's incite and support not only for this project but for the TCRB in general. LoveWorks has volunteered to assist the regions by offering music and a motivational message if the regional board agrees. One suggestion would be for the possibility of having a conference with the families and on the facility grounds and another the same day at a church or conference center. The format would be developed by the various regions and the on-ground facility conference is just an option. Each region will have the complete support of the TCRB, and we offer our assistance to the local and regional boards.

I am submitting this attachment to the board now before the meeting for two reasons 1) to give you an opportunity to digest these concepts and 2) I might be late to the meeting due a Zoom meeting with Ethiopian and Sudanese DOC officials along with New Mexico representatives. I will explain when I arrive approximately at 10:00. To be included in old business are topics of 1) TCRB 50\2c3, 2) TCRB Website transfer from Thurston. 3) FIC FB transfer.
