

FFY2024 Tennessee State and Local Cybersecurity Grant Program Funding Availability Notification

District Representatives and Local Governments:

Tennessee's Strategic Technology Solutions (TN STS) is pleased to announce Federal Fiscal Year 2024 Tennessee State and Local Cybersecurity Grant Program (FFY2024 TN SLCGP) funding availability. The purpose of this FFY2024 TN SLCGP notification is to not only alert you to the availability of funding, but to provide you with the necessary information to apply.

The SLCGP is a financial assistance program that provides funds to build capabilities at the State and local levels through planning equipment, and training activities and to implement the goal and objectives of the state and federal cybersecurity strategies. TN SLCGP is tied to local needs identified through the Nationwide Cybersecurity Review (NCSR). The NCSR will be available in November 2025. Contact ncsr@tn.gov if you have questions about completing the NCSR.

The total amount of funding available for local entities this year, year three of four, is approximately \$6,000,000.00. Three types of projects are eligible for funding through FFY2024 TN SLCGP.

- Project 1 is Cybersecurity Detection and Response-Endpoint Detection and Response.
- Project 2 is Access to end-user cybersecurity training for all local government employees.
- Project 3 is Direct reimbursement for cybersecurity gaps identified in your completed NCSR assessment; these are Cost-Reimbursement Projects.

If you choose to apply for the funds, complete the attached Local Government Investment Justification Form and submit via email form to STS representatives at cybersafetn@tn.gov by, December 12, 2025, at 12 p.m. CT/ 1 p.m. ET. If your proposed projects are selected for funding, TN STS will provide additional notifications and further instructions.
