 - "Seniors" "Elderly" "Aging Dependents" also known as "other-ing"
 - Using "Ageism" without explanation
- Try this:
 - Talking affirmatively about changing demographics: "As Americans live longer"
 - Use more neutral terms: "Older Americans/People" and be inclusive "We" and "Us" instead of "They"
 - Define ageism: "Ageism is the discrimination against older people due to negative and inaccurate stereotypes."

- Questions:
 - Family Support and OPTIONS can be used at the same time, as long as the services do not overlap.
 - Regina asked, how do we find case management? A lot of communities do not have people to check in on them.
 - Lauren stated that housing for older residents is income based.
 There are large overlaps and issues, and housing is one of them. It is going to take a lot to solve the housing issue.
 - Tier 1 Home for the aged allows for providers to license homes with three residents or less. People can apply for it now.
 - Seth stated there is a new DDA unit called the Housing Innovation Unit, under Jeremy Norden Paul. He is also working on the housing barriers and DDA has partnered with the Kelsey to find housing solutions.
 - Alison Moore is the DDA Director of Housing Innovation and is working both with the Aging community and the DDA community.

PRESENTATION: FAMILY SUPPORT SATISFACTION SURVEY RESULTS PRESENTATION FY 23-24

Presented by Jenna Martin

- Survey Submissions
 - 10% of the total Family Support Participants were sent a survey (246) to collect their feedback
 - 115 surveys were completed in English
 - 2 were completed in Spanish
 - Total completed 48%
- Surveys were received from several counties across Tennessee. Received two surveys in Spanish from Rutherford and Hamblen County
- Many participants in the survey answered "always" to the question, Has Family Support made your life easier?
- Where did you meet the Family Support Coordinator?
 - Phone Call 31%
 - At the Agency 27%
 - Email 19%
 - My Home 13%
 - Public Place 6%
 - Other 4%
 - Spanish two participants by phone
- What would happen if this support was no longer available?
 - I could not pay for respite or personal assistance 26%
 - I could not get medicine, food supplements, supplies or equipment –
 21%
 - I could not attend day programs, medical appointments 13%

- I would not be able to spend quality time by myself 12%
- Other 11%
- My family member could not attend activities outside the home and/or my family member would have to live somewhere else – 6.9%
- I could not stay in my home 5.6%
- I would not be able to work 5.2%
- How did you hear about the Family Support Program?
 - Top 3 responses
 - Friend
 - TEIS
 - Another parent
- Do you have additional needs not currently met by the Family Support Program or other programs?
 - No 73%
 - Yes 27%
- Additional Needs not being met by Family Support
 - Various answers, but a few examples:
 - Additional respite time for traveling
 - Extra assistance with hardship bills
 - Finding Behavioral Services
 - Behavioral Therapy (only because it cost more than allotted)
- Comments from families to Tennessee Legislature who approve funding for the Family Support Program
 - Several positive comments were made and are available on the PowerPoint presentation.

COMMITTEE UPDATES

POLICY PROCEDURES EVALUATIONS COMMITTEE

- HB1330/SB1316 "Less is More Act of 2025"
 - Chrystal first noted that the discussion regarding the service animal definition was in the Public Awareness committee, and not this committee.

- The bill will go into effect July 1, 2025. If a governing body has the
 meeting electronically, the meeting will need to be recorded and posted
 on the website.
- Will this affect District Councils and will it affect the committee
 meetings? It should not affect those or the provider meetings. Should
 only affect the State Council meetings. In person meetings will still have
 an electronic option.
- Seth stated that there was a recent amendment updating the bill. The bill that was signed by the Speakers is set to go into effect July 1, 2025.
 Only change would be if the Governor vetoed it. Still some potential for this to change but as it exists, we are already meeting the standards.
 Does require the meetings to be recorded and within three business days posted to the DDA website. We will remain as we have been meeting as the format.
- Errol asked if the roll call vote remains
- Seth stated yes
- Regina asked if this was specifically for State meetings, or will this roll down to Local and District Councils?
- Seth stated that the opinion provided by the AG's Office from a few years ago was that the FS Local and District Councils are not considered governing bodies for purposes of the public meetings act. That's the position from the Attorney General's office and DDA. It only affects the State Council meetings.

PUBLIC AWARENESS TRAINING AND NOMINATION COMMITTEE

- Rebrand Flyer
 - Reviewed as a committee and made some changes. Revisions have been made.
 - They have to be approved by the Council.
 - English is on one side and Spanish is on the other side.
- Rebranded Brochure
 - In the middle of the brochure, families want to know who is eligible and it is outlined who is eligible.

- Explains at the bottom who is not eligible.
- Link to DDA website and QR code for Pathfinder and DDA
- Examples of how Family Support can help people including service options.
- Has been sent to coordinator agencies to confirm that their contact information is correct.
- Misty asked that the phone number for Pacesetters be listed as 931-537-9100.
- Cooper asked, is how to apply included?
- Jenna stated that it is on the front page
- Edward asked if there is any way we can bullet point those programs in bold with a bullet point? Under the section under "Who is eligible for Family Support"
- Jenna stated that there may be a spacing issue, but we can ask him to italicize that section.
- Chrissy asked if we feel like italics or bolding would be more beneficial?
- Jenna stated that we can do both
- Claressa stated that people are more visual and possibly adding more pictures.
- Jenna stated that it makes it difficult due to the spacing issue but will make the recommendation.
- Christy Jensen stated that the picture on the front cover is beautiful, but the person has passed away and may want to choose a different photo.

Service Animal Definition

- Chrissy stated that there has been a lot of discussion over ADA and federal law, the Department of Justice and the addition of miniature horses.
- Proposal from the committee is to use the federal definition from the ADA of "service animal," which only includes dogs, but if a miniature horse request comes up, then the Local Council can choose whether or not to approve. Even then, a dog and a miniature horse are the only 2 animals that are approved for the Family Support Program. We can also reference it in the appropriate and not appropriate section.



- Errol stated that since this is coming as a motion from the committee, we don't need a second.
- Service Animal Definition-Service Animal services under the Family Support program are for the training and/or costs for a "service animal" for use by the person with a disability, as the term "service animal" is defined pursuant to 28 C.F.R. § 35.104 of the Code of Federal Regulations, which is: "any dog that is individually trained to do work or perform tasks for the benefit of an individual with a disability, including a physical, sensory, psychiatric, intellectual, or other mental disability." As further noted in 28 C.F.R. § 35.104, "[o]ther species of animals, whether wild or domestic, trained or untrained, are not service animals for the purposes of this definition." Further, the "work or tasks performed by a service animal must be directly related to the individual's disability" and therefore this service does not include costs for an animal obtained for the "crime deterrent effects of an animal's presence" or "the provision of emotional support, well-being, comfort or companionship." If a miniature horse, as defined by federal law, meets the same criteria as provided above, a Local Council may consider approval of services for the miniature horse.

Jenna stated that she and the Regional Coordinators meet monthly to see how things are going in the regions. Because we see different Local Councils and District Councils, we took the initiative to streamline the process. The goal is to give the empowerment to the Local Council chairs and District Council chairs to take ownership of their meetings. Local Council and District Council chairs were invited to the Public Awareness Training and Nominating Committee meeting so everyone can get the same information. The PowerPoint was shared with the group. A summary and training were provided to outline roles and responsibilities of the Chairs, Agency Coordinators, and Regional & Statewide Family Support Staff.

QUARTERLY FINANCIAL REPORT

The overview of the third quarter financial report is provided below. The following statewide statistical information is from the third quarter financial report as of 5/6/25.

- The total number of Family Support Active Participants in the third quarter was 4,702.
- **14%** of active participants have an intellectual disability.
- 86% of active participants have a severe or developmental disability other than an intellectual disability.
- Autism Spectrum Disorder continues to be the highest served disability 1,637
- Intellectual Disability is the second highest served disability 669
- Developmental Delay is the third highest served disability 494
- Health impairment is the fourth highest served disability 487
- The number one service type continues to be Respite 18.38%
- The second highest service type was Personal Assistance 17.13%
- The third highest service type was Transportation 12.76%
- The fourth highest service type was Health Related 8.88%
- \$7,147,479.21.78 was allotted, \$5,030,778.75 was disbursed, \$2,116,700.46 was remaining according to the report.
 - At the end of the third quarter, there were 378 waiting recipients for the Family Support Program.
