

## 2023-24 Federal Accountability Files and Timelines

### May 2024

This document provides an estimated timeline for major 2023-24 accountability file releases from the Tennessee Department of Education (department) on the Accountability application. Please note that the timeline is an *estimate* and is subject to change based on the timing of delivery of data and the quality assurance process. The department will communicate all releases to districts through the *Commissioner's Update for Directors* and other accountability communication channels (i.e., monthly email, office hours).
