Description

The OSHA 10-Hour General Industry certification allows students to increase their value as entry-level workers by demonstrating mastery of the recognition, avoidance, abatement, and prevention of safety and health hazards in the general industry workplace. The program also provides information regarding workers' rights and employer responsibilities. OSHA training and certification ensures that workers are more knowledgeable about workplace hazards and their rights. Students who obtain the OSHA 10-Hour General Industry certification will develop a safety mindset and acquire marketable skills for a competitive edge.

Registration Procedures

- 1. For online testing, the school must purchase a voucher number or access code for each student or a site-license from an authorized online training provider.
- 2. For testing with a certified trainer, the certified trainer will provide instructions for student registration.
- 3. For testing by an OSHA certified teacher trainer, the training will include information regarding how to register students.

Preparing to offer the certification

Exam Details:

For OSHA recognition, the training and testing of students **must** be carried out in <u>one</u> of the following three ways:

- 1. Students use an approved online OSHA training test owner for training and test administration.
- 2. Students are taught by a certified OSHA trainer: Certified trainers may be located by contacting:
