#### **Description**

TN Cosmetologist 1010 is a two portion exam: theory portion and practical portion. It covers the following:

- A cosmetologist performs, for compensation, arranging, dressing, curling, waving, cleansing, cutting, singeing, bleaching, coloring, or similar work on the hair;
- care for or service wigs or hair pieces;
- manicure; massage, clean, stimulate, manipulate, exercise, beautify or perform similar work
  upon the hands, arms, face, neck, or feet with hands or by use of cosmetic preparations, tonics,
  lotions or creams;
- place or apply artificial eyelashes, give facials, apply makeup, give skin care, or remove superfluous hair by tweezing, depilatories, or waxing.
- Effective July 1, 2015, a cosmetologist may shave using a safety razor.
