June 1, 2022 Participating Private Schools: Participating private school graduation and completion rates of 12<sup>th</sup> grade students in the IEA Program for 2021-22 must be received by the department by 3:00 p.m. CT

June 1, 2022 Account Holders: Graduation/post-secondary information due.  
*\*Renewal info: If your student has graduated and/or will be participating in any post-secondary coursework during the 2022-23 school year, you must notify [IEA.Questions@tn.gov](mailto:IEA.Questions@tn.gov) and provide a copy of the student's diploma and/or verification of dual enrollment placement for 2022-23.*
