# **General Information**

### Background

The Tennessee Comprehensive Assessment Program (TCAP) tests all students per state and federal law in the State of Tennessee. Within this program lies the development of items, building of item banks, and using these approved items to form the tests given to students each year. The Tennessee Department of Education is seeking qualified consultants to review these items.

#### **Procurement Purpose**

The department is seeking two social studies consultants to aide in the approval of the development items for the TCAP testing program.

The budget for this project is \$20,000.00 (Speedchart number: ED0000034) which will include two \$10,000.00 purchase order contracts. The selected vendors must sign the State's purchase order terms and conditions prior to the start of work.
