The commissioner's waiver authority under Tenn. Code Ann. § 49-1-201(d) is limited by Tenn. Code Ann. § 49-1-104(a), which states that "neither the commissioner nor the state board of education shall grant waivers from the maximum class sizes established in this section."

With the understanding that none of the grades 6-8 CTE/Encore courses in Bledsoe County Schools will exceed the maximum number of students per class specified in the above referenced law, your request for a waiver of the class size average is hereby granted the 2026-27 school year.
