Dear Director Briscoe:

I have received your waiver request of Tenn. Code Ann. § 49-6-3004 as it pertains to the required 180 days of classroom instruction. Grainger County Schools were closed January 10-23, 2025, due to the Level 3-State of Emergency. You are requesting a waiver for January 10, 2025, and January 13-17, 2025.

Under Tenn. Code Ann. § 49-6-3004(a)(6), the commissioner has the authority to waive the 180 days for classroom instruction requirement in the event of a natural disaster or serious outbreaks of illness affecting or endangering students or staff. Pursuant to this authority and given Grainger County Schools have exhausted all stockpile days, the waiver request for January 10, 2025, and January 13-17, 2025, is hereby granted.

Commissioner Reynolds,

During early January, the entire State of Tennessee experienced a severe winter storm negatively impacting the Grainger County School System. Grainger County Schools were closed from January 10<sup>th</sup> through January 23<sup>rd</sup>. When classes resumed on January 24<sup>th</sup>, our school system couldn't even run all our bus routes. Although we do stockpile days, we have exhausted those days due to the snow and ice. We have used all ten stockpiled days for these two events. The other three stockpiled days are for staff development.

At the direction of Governor Bill Lee, TEMA Director Patrick C. Sheehan issued a State of Emergency to provide regulatory relief due to winter weather in Tennessee on Thursday, January 9, 2025. During a state of emergency, certain state laws can be suspended to expediate relief efforts in the affected areas.

I am requesting a waiver of the instructional day requirement under Tenn. Code Ann. § 49 -6 - 3004(a) (6) which authorizes the Commissioner of Education to grant a waiver requirement in the event of a natural disaster or a serious outbreak of illness affecting or endangering students or staff during the school year. This waiver request is for the following six days:

Friday, January 10<sup>th</sup>; Monday, January 13<sup>th</sup>; Tuesday, January 14<sup>th</sup>; Wednesday, January 15<sup>th</sup>; Thursday, January 16<sup>th</sup>; and Friday, January 17<sup>th</sup>.
