Re: Waiver for Remote Instruction

Dear Director McClain:

I am in receipt of the October 14, 2024, waiver request of Tenn. Code Ann. § 49-6-3004(i) as it relates to remote instruction. Tenn. Code Ann. § 49-6-3004(i)(1) allows school districts to provide up to two (2) days each semester of the required one hundred eighty (180) days of classroom instruction via remote instruction in the event of dangerous or extreme weather conditions or of serious outbreak of illness affecting or endangering students or staff or for the administration of assessments. Additionally, Tenn. Code Ann. § 49-6-3004(i)(7) requires school districts to make meals available to students in accordance with the school nutrition program requirements on days that remote instruction is provided.

You have requested to use one remote instruction day on November 5, 2024, due to the observation of Election Day.

Pursuant to the commissioner's waiver authority under Tenn. Code. Ann. § 49-1-201(d)(1), your request of a waiver of Tenn. Code Ann. § 49-6-3004(i)(1) and Tenn. Code Ann. § 49-6-3004(i)(7) is hereby granted to allow the use of the aforementioned remote learning day without the requirement to serve meals due to the observation of Election Day. Please do not hesitate to contact me if you have further questions.
